## AN ORDINANCE OF THE CITY OF WILDWOOD, MISSOURI, AMENDING SECTION 210.220 OF THE CODE OF ORDINANCES OF THE CITY OF WILDWOOD, MISSOURI, BY DELETING PARAGRAPH 7 OF SUBSECTION (C) IN ITS ENTIRETY, AND ENACTING, IN LIEU THEREOF, A NEW PARAGRAPH 7 OF SUBSECTION (C); PROVIDING REGULATIONS FOR SPECIAL HUNTS IN THE CITY.

## BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WILDWOOD, MISSOURI, AS FOLLOWS:

Section One. That paragraph 7 of subsection (C) of Section 210.220 of the Code of Ordinances of the City of Wildwood, Missouri, shall be and hereby is amended by deleting paragraph 7 of subsection (C) of Section 210.220 of the Code of Ordinances of the City of Wildwood, Missouri in its entirety, and enacting, in lieu thereof, a new paragraph 7 of subsection (C) of Section 210.220 to read, as follows:

7. Special Hunts. Nothing contained herein or in Section 210.225(A)(3)&(8) of this Code shall apply to any person authorized by the City to participate in any special hunts permitted by the Missouri Department of Conservation, Department of Natural Resources or the St. Louis County Parks Department after obtaining approval of the City Council of the City of Wildwood.

<u>Section Two.</u> <u>Savings.</u> Nothing contained herein shall in any manner be deemed or construed to alter, modify, supersede, supplant or otherwise nullify any other Ordinance of the City or the requirements thereof whether or not relating to or in any manner connected with the subject matter hereof, unless expressly set forth herein.

<u>Section Three.</u> <u>Severability.</u> If any term, condition, or provision of this Ordinance shall, to any extent, be held to be invalid or unenforceable, the remainder hereof shall be valid in all other respects and continue to be effective and each and every remaining provision hereof shall be valid and shall be enforced to the fullest extent permitted by law, it being the intent of the City Council that it would have enacted this Ordinance without the invalid or unenforceable provisions. In the event of a subsequent change in applicable law so that the provision which had been held invalid is no longer invalid, said provision shall thereupon return to full force and effect without further action by the City and shall thereafter be binding.

**Section Four.** This Ordinance shall be in full force and effect from and after its final passage and approval.
