

AN ORDINANCE OF THE CITY OF WILDWOOD, MISSOURI, AMENDING CHAPTER 390 OF THE CODE OF ORDINANCES OF THE CITY OF WILDWOOD, MISSOURI, BY ESTABLISHING TURNING AND DIRECTIONAL MOVEMENT RESTRICTIONS FOR STATE ROUTE 109 AT TURKEY TRACK ROAD AND AT THE COMMERCIAL DRIVEWAY AT 2641 STATE ROUTE 109 WITHIN THE CITY, AND AUTHORIZING AND DIRECTING THE CITY TRAFFIC ENGINEER TO ERECT APPROPRIATE SIGNAGE REFLECTING SUCH TURNING AND DIRECTIONAL MOVEMENT RESTRICTIONS.

WHEREAS, pursuant to § 304.120.2(1), RSMo., “Municipalities, by ordinance, may . . . [m]ake additional rules of the road or traffic regulations to meet their needs and traffic conditions;” and

WHEREAS, the City Council of the City of Wildwood, Missouri (the “City”), desires to provide improved safety at all times for residents of the City; and

WHEREAS, the City Council of the City finds and determines that traffic regulations on left turn movements should be implemented on State Route 109 and the commercial entrance for the development at 2641 State Route 109 and at State Route 109 and Turkey Track Lane, in order to promote the general health, safety and welfare of the residents of the City.

NOW THEREFORE, BE IT ORDAINED, BY THE COUNCIL OF THE CITY OF WILDWOOD, MISSOURI, AS FOLLOWS:

Section One. That Chapter 390, Traffic Schedule IV, Turning and Directional Movement Restrictions, of the Code of Ordinances of the City of Wildwood shall be and it is hereby amended by enacting the following regulations, as set forth in *italics* below:

SCHEDULE IV. TURNING AND DIRECTIONAL MOVEMENT RESTRICTIONS

<u>Location</u>	<u>Regulation</u>
<i>Missouri Route 109 and Turkey Track Lane</i>	<i>No Left Turn for Eastbound traffic on Turkey Track Lane No Left Turn for Northbound traffic on Missouri Route 109 No Right Turn for Southbound traffic on Missouri Route 109</i>

<u>Location</u>	<u>Regulation</u>
<i>Missouri Route 109 and Commercial Entrance at 2641 Route 109</i>	<i>No Left Turn for Eastbound commercial entrance traffic No Left Turn for Northbound traffic on Missouri Route 109</i>

Section Two. The City Traffic Engineer is hereby authorized and directed to erect appropriate signage providing notice of the traffic regulations established pursuant to Section One of this Ordinance.

Section Three. Violations of the traffic regulations established pursuant to this Ordinance shall be prosecuted pursuant to the Traffic Code of the City of Wildwood and will be controlled and

enforced by the St. Louis County Police Department pursuant to its contract with the City, as amended.

Section Four. Savings. Except as expressly set forth herein, nothing contained in this Ordinance shall in any manner be deemed or construed to alter, modify, supersede, supplant or otherwise nullify any other Ordinance of the City or the requirements thereof whether or not relating to or in manner connected with the subject matter hereof.


Section Five. Severability. If any term, condition, or provision of this Ordinance shall, to any extent, be held to be invalid or unenforceable, the remainder hereof shall be valid in all other respects and continue to be effective and each and every remaining provision hereof shall be valid and shall be enforced to the fullest extent permitted by law, it being the intent of the City Council that it would have enacted this Ordinance without the invalid or unenforceable provisions. In the event of a subsequent change in applicable law so that the provision, which had been held invalid is no longer invalid, said provision shall thereupon return to full force and effect without further action by the City and shall thereafter be binding.

Section Six. This Ordinance shall be in full force and take effect from and after the date of its final passage and approval.

This Bill was passed and approved this 10th day of June, 2024, by the Council of the City of Wildwood, Missouri, after having been read by title or in full two (2) times prior to passage.
