

ORDINANCE NO. 2364

**AN ORDINANCE AMENDING CHAPTER 282, DRIVEWAY LOCATION, DESIGN AND
CONSTRUCTION REQUIREMENTS
OF THE CODE OF THE VILLAGE OF WINNECONNE
TO REVISE DRIVEWAY REQUIREMENTS**

The Board of Trustees of the Village of Winneconne do ordain as follows:

Section 1. Section 282-2(A)(2), Driveway location, design, and construction requirements, is hereby amended to read as follows:

(2) Number. The number of driveways to serve an individual property fronting on a street shall be:

- a. One per Residential Property
- b. Two per commercial unit if the frontage is greater than 300 feet,

except where deemed necessary and feasible by special permission from the Public Works Committee for reasonable and adequate service to the property, considering the safety, convenience and utility of the street.

Section 2. Section 282-2(A)(4), Driveway location, design, and construction requirements, is hereby amended to read as follows:

(4) Reconstruction of sidewalks and curb and gutter. When the construction of a driveway requires the removal of a curb and gutter, the new connections shall be of equivalent acceptable material and curb returns shall be provided or restored in a neat, workmanlike manner. The driveway surface shall be connected with the highway pavement and the sidewalk, if any, in a neat, workmanlike manner.

- a. The driveway apron from the street and/or curb to the outer edge of the adjacent sidewalk (or where a sidewalk would typically be constructed) shall be paved with concrete.
- b. The Maximum and minimum specifications for driveway approaches shall be as follows:
 - i. Residential:
 1. Maximum permitted width of entrance 30 feet.
 2. Minimum permitted width of entrance is 13 feet.
 3. Maximum permitted curb cut 35 feet.
 4. Minimum permitted curb cut is 18 feet.
 - ii. Residential Multifamily:
 1. Maximum permitted width of entrance 35 feet.
 2. Maximum permitted curb cut 40 feet.
 - iii. Commercial:
 1. Maximum permitted width of entrance 45 feet.


2. Maximum permitted curb cut 70 feet.
- c. The driveway construction shall include the replacement of such sidewalk areas which are inadequate, or which are or may be damaged by means of vehicle travel across the sidewalk. Reconstructed or new sidewalks shall meet the construction standard of Chapter 460, Streets and Sidewalks, Article II, Construction and Repair of Sidewalks, of the Code of the Village of Winneconne.

Section 3. All other provisions of Chapter 282 shall remain unchanged by this ordinance.
