## SECOND READING

### AN ORDINANCE AMENDING CHAPTER 7 ENTITLED "TRAFFIC", SECTION

## 7-39 OF THE REVISED ORDINANCES OF THE TOWNSHIP OF WOODBRIDGE

# BE IT ORDAINED BY THE MUNICIPAL COUNCIL OF THE TOWNSHIP OF WOODBRIDGE AS FOLLOWS:

Chapter 7, Section 7-39 Control for the Movement and the Parking of Traffic on Public and Private Property, Subsection 7-39.1 Regulation for the Movement and the Parking of Traffic on Municipal Property and Board of Education Property is amended as follows to read:

"d. Property: North James Street Municipal Parking Lot. (South Side of North James Street and North Side of North James Street)

#### Regulations:

- 1. General parking.
  - (e) No person shall park any vehicle other than within the boundary lines of a parking space. No person shall wash, paint, repair or otherwise work on any vehicle parked in a Municipal Parking Lot (lower level parking deck only); provided, however, that nothing contained herein shall be construed to prohibit necessary emergency repairs to a vehicle.
  - (f) No person shall enter or park in the North James Street Municipal Lot unless such person is:
    - (1) Merchant of the Main Street Business District
    - (2) Employee of merchant of the Main Street Business District
    - (3) Shopper/Diner of the Main Street Business District
    - (4) Employee/Visitor of Ross Street School (School #11)
  - (g) Parking will be limited to a maximum of four (4) hours in all parking spaces between the hours of 8:00 a.m. and 4:00 p.m. Monday through Friday. Exception: The four (4) hour parking time limit will not apply to any person who has applied for and obtained a parking permit from the Woodbridge Police Department. Permits will be available to any merchant of the Main Street Business District.
  - (h) No vehicles shall be parked in this municipal parking facility between the hours of 2:00 a.m. and 7:00 a.m. (this does not apply to vehicles registered to the Township of Woodbridge)."

All ordinances or parts of ordinances inconsistent with or in conflict with this ordinance are hereby repealed to the extent of such inconsistency.

If any section, paragraph, clause or provision of this ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, clause or provision so adjudged and the remainder of the ordinance shall be deemed valid and effective.

This ordinance shall become effective 20 days after adoption and publication according to law.
