AN ORDINANCE AMENDING CHAPTER 10 ENTITLED "TAXICABS AND LIMOUSINES" OF THE REVISED ORDINANCES OF THE TOWNSHIP OF WOODBRIDGE

SECTION I.

BE IT ORDAINED BY THE MUNICIPAL COUNCIL OF THE TOWNSHIP OF WOODBRIDGE that Chapter 10, Taxicabs and Limousines, Section 10-2 Taxicab Licenses, Subsection 10-2.5 Insurance Requirements is hereby amended as follows: 10-2.5(a)(1) and (a)(2) shall be deleted in their entirety and replaced with the following:

2.5 Insurance Requirements

(a) No taxicab license shall be issued until the applicant for a taxicab license (the owner of the taxicab) shall have first filed with the Township Clerk an insurance policy of a company duly licensed to transact business under the insurance laws of New Jersey, conditioned for the payment of a sum not less than one million five hundred thousand (\$1,500,000.00) dollars to satisfy all claims for damages on account of property damage, bodily injury or death suffered by any person as the result of an accident occurring by reason of the ownership, maintenance or use of the taxicab upon any public street. For taxicab owners who are already licensed by the Township at the time of the adoption of this Ordinance, the increased insurance requirement shall take effect at the time of the first renewal of the taxicab owner's insurance policy for the taxicab.

BE IT FURTHER ORDAINED BY THE MUNICIPAL COUNCIL OF THE TOWNSHIP OF WOODBRIDGE that Chapter 10, Taxicabs and Limousines, Section 10-10 Limousine Licenses, Subsection 10-10.5 Insurance Requirements is hereby amended as follows: 10-10.5(a)(1) and (a)(2) shall be deleted in their entirety and replaced with the following:

10.5 Insurance Requirements

(a) No limousine license shall be issued until the applicant for a limousine license (the owner of the limousine) shall have first filed with the Township Clerk an insurance policy of a company duly licensed to transact business under the insurance laws of New Jersey, conditioned for the payment of a sum not less than one million five hundred thousand (\$1,500,000.00) dollars to satisfy all claims for damages on account of property damage, bodily injury or death suffered by any person as the result of an accident occurring by reason of the ownership, maintenance or use of the limousine upon any public street. For limousine owners who are licensed by the Township at the time of the adoption of this Ordinance, the increased insurance requirement shall take effect at the time of the first renewal of the limousine owner's insurance policy for the limousine.

SECTION II. All ordinances or parts of ordinances inconsistent with or in conflict with this ordinance are hereby repealed to the extent of such inconsistency.

SECTION III. If any section, paragraph, clause or provision of this ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, clause or provision so adjudged and the remainder of the ordinance shall be deemed valid and effective.

SECTION IV. This ordinance shall become effective 20 days after adoption and publication according to law.
