

**AN ORDINANCE OF THE TOWNSHIP OF WOOLWICH AMENDING CHAPTER 182 OF THE
WOOLWICH TOWNSHIP CODE ENTITLED "VEHICLES AND TRAFFIC" TO CREATE VARIOUS
STOP CONTROL AREAS FOR INCREASED PEDESTRIAN AND VEHICLE SAFETY
2025-16**

WHEREAS, from time to time it becomes necessary to amend ordinances to promote the best interests of the Township of Woolwich; and

WHEREAS, it is in the best interest of the Township of Woolwich and its residents to create STOP CONTROLLED AREAS for increased pedestrian and vehicle safety within the Township of Woolwich; and

WHEREAS, Chapter 182-14 of the Code of the Township of Woolwich designates stop intersections; and

WHEREAS, the Mayor and Township Committee of the Township of Woolwich deems it is in the best interest of the health, safety and welfare of its residents and the Township to amend Chapter 182 of the Woolwich Township Code Entitled "Vehicles and Traffic" to create additional stop control areas; and

WHEREAS, this Ordinance is amended for such purpose.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Woolwich as follows:

SECTION 1 Amendment

Chapter 182, Section 14 entitled "Designation of Stop Intersections" shall be amended to add the following:

Sweetgum Street & Weston Drive - All 3 Corners

Merseyside Drive & Weston Drive - All 3 Corners

Balsam Road & Weston Drive - All 3 Corners

Cornwall Drive & Kent Street - Both Sides of Kent Street

Inconsistency:

All Ordinances or parts of Ordinances that are inconsistent with the terms of this Ordinance are hereby repealed to the extent of their inconsistency.



IT IS FURTHER ORDAINED that appropriate signage is hereby authorized pursuant to standards contained in the Manual of Uniform Traffic Control Devices.


Effective Date:

NOTICE


