

**AN ORDINANCE AMENDING ORDINANCE 2025 OF THE CITY OF WOODSON TERRACE, RELATING TO THE COMPENSATION OF MEMBERS OF THE POLICE DEPARTMENT**

**BE IT ORDAINED** by the Board of Aldermen of the City of Woodson Terrace, St. Louis County, Missouri, as follows:

**SECTION 1.**

Ordinance 2024 is hereby amended by deleting the salary schedule and replacing it with additional pay grades and increases as follows:
