ORDINANCE 2017 – 04**

**AN ORDINANCE TO AMEND AND SUPPLEMENT  
CERTAIN PROVISIONS OF CHAPTER 210 ENTITLED  
“VEHICLES & TRAFFIC” OF THE CODE OF THE  
BOROUGH OF WRIGHTSTOWN**

**WHEREAS**, the Borough of Wrightstown continually undertakes to review safety conditions on the Borough’s roadway system located within the Borough as part of its long term goal to improve safety conditions on roadways located in the Borough and neighborhoods; and

**WHEREAS**, the safety of Borough residents and members of the general public utilizing Borough and County Roads located within the Borough may be endangered by vehicles turning left onto Fort Dix Street (County Road 545) from property located at 101 Fort Dix Street, and more specifically designated as Block 402, Lots 7 & 8 on the Wrightstown Borough Tax Map; and

**WHEREAS**, as a condition of Site Plan approval for the proposed construction of a Dunkin Donuts with a drive-thru and improvements for the property located at 101 Fort Dix Street, and more specifically designated as Block 402, Lots 7 and 8 on the Borough of Wrightstown Tax Map, the County of Burlington has requested that the Borough of Wrightstown adopt an Ordinance prohibiting left turns onto Fort Dix Street (County Road 545) from a proposed Fort Dix Street Access from the property located at 101 Fort Dix Street and more specifically designated as Block 402, Lot 7 & 8 on the Borough of Wrightstown Tax Map.

**NOW THEREFORE, BE IT ORDAINED AND ENACTED** by the Borough of Wrightstown, County of Burlington, State of New Jersey, that Article III (“Traffic Regulations”) Code of the Borough of Wrightstown be and is hereby amended and supplemented as follows:

**Section One.** Article III, Chapter 210-19, Schedule XIV is hereby amended and supplemented to add the following provision:

**Supplemental Section.**

- A. Vehicles are hereby prohibited from making left-hand turns onto Fort Dix Street (County Road 545) from property located at 101 Fort Dix Street, and more commonly known as Block 402, Lots 7 & 8 on the Borough of Wrightstown Tax Map.

**Section Two. Repealer, Severability and Effective Date.**

- A. Repealer. Any and all Ordinances inconsistent with the terms of this Ordinance are hereby repealed to the extent of any such inconsistencies.

- B. Severability. In the event that any clause, section, paragraph or sentence of this Ordinance is deemed to be invalid or unenforceable for any reason, then the Borough Committee hereby declares its intent that the balance of the Ordinance not affected by said invalidity shall remain in full force and effect to the extent that it allows the Borough to meet the goals of the Ordinance.
- C. Effective Date. This Ordinance shall take effect upon proper passage in accordance with the law.

### **NOTICE**

The ordinance published herewith was introduced and passed upon first reading at a meeting of the Borough Council of the Borough of Wrightstown held on April 26, 2017. It will be further considered for final passage after a public hearing at the regular meeting to be held on May 10, 2017, at the Borough Hall, 21 Saylor's Pond Road, Wrightstown, New Jersey at 6:30 P.M. at which time and place any persons desiring to be heard upon the same will be given an opportunity to be heard.
