ORDINANCE #2019-06**

**AN ORDINANCE AMENDING CHAPTER 132, ENTITLED
PARKS AND RECREATION, OF THE CODE OF THE BOROUGH OF
WRIGHTSTOWN, NEW JERSEY**

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF WRIGHTSTOWN, IN THE COUNTY OF BURLINGTON, STATE OF NEW JERSEY AS FOLLOWS:

Section One: Chapter 132 of the Code of the Borough of Wrightstown is hereby amended as set forth in this Ordinance.

Section Two: Section 132-6 is amended to add Subsection F as follows:

“F. A returnable security deposit of \$200.00 is required with all applications. This deposit will be used to cover damage to Borough property or cleaning required due to the use of the site. After the permit holder’s use of the property, the Borough shall inspect the property. If no damage is identified and cleanup is not required, the security deposit shall be returned. If damage is identified or cleanup is required, the permit holder and/or organization, jointly and severally, shall be responsible for all repair or cleanup costs. Users will be notified in writing by the Borough Clerk if any such charge will be assessed and if the cost is greater than the initial deposit required.”

Section Three: All other provisions of Section 132-6 shall remain unchanged and in full force and effect.

Section Four: Sections of Chapter 132 unaffected by this Ordinance shall remain in full force and effect.

Section Five: If any sentence, paragraph or section of this Ordinance, or the application thereof to any person or circumstances shall be adjudged by a court of competent jurisdiction to be invalid, or if by legislative action any sentence, paragraph or section of this Ordinance shall lose its force and effect, such judgment or actions shall not affect, impair or void the remainder of this Ordinance.

Section Six: This Ordinance shall become effective immediately upon final passage and publication in accordance with law.

Section Seven: All other Ordinances or parts of Ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

NOTICE

The ordinance published herewith was introduced and passed upon first reading at a meeting of the Borough Council of the Borough of Wrightstown held on July 10, 2019. It will be further considered for final passage after a public hearing at the regular meeting to be held at 6:30 PM on August 14, 2019 at the Borough Hall, 21 Saylor's Pond Road, Wrightstown, New Jersey, at which time and place any persons desiring to be heard upon the same will be given an opportunity to be heard.
