ORDINANCE #2022-02**

**AN ORDINANCE AMENDING CHAPTER 210, ENTITLED
VEHICLES AND TRAFFIC, OF THE CODE OF THE BOROUGH OF
WRIGHTSTOWN, NEW JERSEY**

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF WRIGHTSTOWN, IN THE COUNTY OF BURLINGTON, STATE OF NEW JERSEY AS FOLLOWS:

Section One: Chapter 210 of the Code of the Borough of Wrightstown is hereby amended as set forth in this Ordinance.

Section Two: Section 210-34, Schedule VI: Trucks in Excess of Four Tons, is amended to add the following to the list of streets or parts of streets over which trucks over four tons are excluded:

Name of Street	Location
Saylors Pond Road	Between Farago Boulevard and Meeting House Road/West Main Street.
West Main Street	Between Meeting House Road/Saylors Pond Road and Fort Dix Street (County Road 545).
East Main Street	Between Fort Dix Street (County Road 545) and Railroad Ave.

Section Three: All other provisions of Section 210-34 shall remain unchanged and in full force and effect.

Section Four: Sections of Chapter 210 unaffected by this Ordinance shall remain in full force and effect.

Section Five: If any sentence, paragraph or section of this Ordinance, or the application thereof to any person or circumstances shall be adjudged by a court of competent jurisdiction to be invalid, or if by legislative action any sentence, paragraph or section of this Ordinance shall lose its force and effect, such judgment or actions shall not affect, impair or void the remainder of this Ordinance.

Section Six: This Ordinance shall become effective immediately upon final passage and publication in accordance with law.

Section Seven: All other Ordinances or parts of Ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

NOTICE

The ordinance published herewith was re-introduced and passed upon first reading at the regular meeting of the Borough Council of the Borough of Wrightstown held on July 27, 2022. It will be further considered for final passage after a public hearing at the regular meeting to be held on August 24, 2022, at the Borough Hall, 21 Saylor's Pond Road, Wrightstown, New Jersey, at 6:30 PM, at which time and place any persons desiring to be heard upon the same will be given an opportunity to be heard.
