BOROUGH OF WRIGHTSTOWN COUNTY OF BURLINGTON, NEW JERSEY ORDINANCE #2024-01

AN ORDINANCE AMENDING CHAPTER 21 OF THE CODE OF THE BOROUGH OF WRIGHTSTOWN, NEW JERSEY, ENTITLED UTILITIES AUTHORITY, MUNICIPAL REGARDING COMPENSATION OF MEMBERS OF THE WRIGHTSTOWN MUNICIPAL UTILITIES AUTHORITY

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF WRIGHTSTOWN, IN THE COUNTY OF BURLINGTON, STATE OF NEW JERSEY AS FOLLOWS:

Section One: Chapter 21 of the Code of the Borough of Wrightstown is hereby amended as set forth in this Ordinance.

<u>Section Two:</u> Section 21-4 is hereby deleted in its entirety and replaced with the following: "Members of the Wrightstown Municipal Utilities Authority may receive from the Wrightstown Municipal Utilities Authority compensation for their services as members, within the limitation hereby stated that no member shall receive in excess of \$1,100 per annum beginning in 2024. Said limitation shall be raised each year by the same percentage that the compensation of the members of the Borough Council is increased in each year."

Section Three: All other provisions of Chapter 21 shall remain unchanged and in full force and effect.

Section Four: Sections of Chapter 21 unaffected by this Ordinance shall remain in full force and effect.

<u>Section Five</u>: <u>Severability</u>. If any sentence, paragraph or section of this Ordinance, or the application thereof to any persons or circumstances shall be adjudged by a court of competent jurisdiction to be invalid, or if by legislative action any sentence paragraph or section of this Ordinance shall lose its force and effect, such judgment or action shall not affect, impair or void the remainder of this Ordinance.

<u>Section Six:</u> <u>Effective Date</u>. This Ordinance shall become effective immediately upon final passage and publication in accordance with the law.

<u>Section Seven:</u> Repealer. All other Ordinances or parts of Ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.
