ORDINANCE NO. 2024-__2_

AN ORDINANCE OF THE BOROUGH OF WRIGHTSVILLE, COUNTY OF YORK, COMMONWEALTH OF PENNSYLVANIA, AMENDING THE CODE OF ORDINANCES, CHAPTER 1, PART 4, ENTITLED "POLICE DEPARTMENT" AND ADOPTING A PLAN AMENDMENT TO THE BOROUGH OF WRIGHTSVILLE POLICE PENSION PLAN TO TERMINATE THE SAME

WHEREAS, on or about January 8, 1962, the Borough of Wrightsville (the "Borough") established the Borough of Wrightsville Police Pension Plan (the "Plan") for the members of the Borough's police force as a permanent qualified plan pursuant to the Pennsylvania Municipal Police Pension Law, known as Act 600, to provide benefits to the officers in the event of retirement; and

WHEREAS, on or about July 1, 2018, the Borough police department became part of the Hellam Township, York County, Pennsylvania police department, with all three (3) Borough police officers becoming officers of the Hellam Township police department; and

WHEREAS, on or about July 1, 2018, the Borough executed a contract with Hellam Township for Hellam Township police department to provide police services to the Borough for an initial term of three (3) years, which Agreement has since been renewed for an additional term expiring on December 31, 2025; and

WHEREAS, the Borough does not employ any police officers, let alone those eligible for Plan participation, and therefore is no longer required to maintain a police pension plan in accordance with Act 600; and

WHEREAS, the Borough-Council has determined that due to the financial implications, it is unlikely it will ever form another Borough police department, and therefore desires to now adopt this Plan Amendment to terminate the Plan; and

WHEREAS, Section 9.4(a) of the Plan provides that the "[P]lan shall terminate ... by the amendment action of the [Borough]"; and

NOW, THEREFORE, it is hereby enacted and ordained by the Borough Council of the Borough of Wrightsville, York County, Pennsylvania and by and through the authority of the same, as follows:

SECTION 1. The Borough of Wrightsville Police Pension Plan is hereby terminated upon enactment of this Ordinance. Gregory Sahd, as the agent of the Employer, is authorized and directed to execute any and all documents necessary to effectuate this amendment to the Plan, and to terminate the same.

SECTION 2: Chapter 1, Part 4, of the Borough Code, entitled "POLICE DEPARTMENT" is hereby repealed in its entirety.

SECTION 3. This Ordinance shall become effective immediately after enactment.

SECTION 4. If any clause, sentence, or other provisions of this Ordinance should be declared unconstitutional, illegal, or invalid, such unconstitutionality, illegality, or invalidity shall not affect the remaining provisions of this Ordinance, and the Borough Council declares that it would have adopted this Ordinance had such unconstitutional, illegal, or invalid provisions not been contained herein.

SECTION 5. All other Ordinances inconsistent with this Ordinance are hereby repealed insofar, but only insofar, as they are inconsistent herewith.
