

# AN ORDINANCE OF THE BOARD OF SUPERVISORS OF WRIGHTSTOWN TOWNSHIP, BUCKS COUNTY, PENNSYLVANIA, AMENDING CHAPTER 16 OF THE CODIFIED ORDINANCES OF WRIGHTSTOWN TOWNSHIP REGULATING OUTDOOR LIGHTING

WHEREAS, the Board of Supervisors of Wrightstown Township, Bucks County, Pennsylvania has enacted an Outdoor Lighting Ordinance; and

WHEREAS, the Board of Supervisors has determined that it is in the best interest of the Township to amend the Lighting Ordinance to require and regulate Light Emitting Diode (LED) light fixtures.

**NOW, THEREFORE**, be it, and it is hereby **ORDAINED** by the Board of Supervisors of Wrightstown Township, Bucks County, Pennsylvania as follows:

## ARTICLE I.

10

Section 16-103.2 of the Wrightstown Township Codified Ordinances is amended by inserting new subsections E, F and G as follows:

E. Lighting as required for Use/Task 1, 2, 3, 4, 5, and 6 listed in the Use/Task Table 16-103.D:

Shall use fixtures that emit a corrected color temperature of 3000K or less. Any fixture that utilizes a color temperature greater than 3000K shall only be permitted with the approval of the Board of Supervisors.

F. All new non-residential outdoor lighting fixtures shall be light emitting diode (LED).

G. The emitting light source in the LED fixture shall be shielded and not visible to achieve effective reduction in glare and light trespass. The LED fixtures shall be full cutoff (zero light above 90 degrees) or fully shielded.

The remaining provisions of Section 16-103 shall remain in full force and effect.

### ARTICLE II.

Section 16-104 shall be amended by adding a new subsection 2 as follows:

2. All street lighting in Residential Developments shall use LED fixtures that emit a corrected color temperature of 3000k or less.

## ARTICLE III.

Section 16-110 shall be revised by deleting subsection 1 and replacing it with the following:

 When street lighting is to be dedicated to the Township, the Applicant shall be responsible for all costs involved in the lighting of the streets and street intersections, until the street is accepted for dedication. All streetlights shall be 3000k LED light fixtures.

The remaining provisions of Section 16-110 shall remain in full force and effect.

### ARTICLE IV.

Any Ordinances or parts thereof inconsistent with the provisions of this Ordinance are hereby repealed to the extent of the inconsistency. All Ordinances unaffected by this Ordinance are hereby declared to be in full force and effect.

#### ARTICLE V.

The provisions of this Ordinance are declared to be severable. If any provision of this Ordinance is declared by a Court of competent jurisdiction to be invalid or unconstitutional, such determination shall have no effect on the remaining provisions of this Ordinance or on the provisions for the Wrightstown Township Outdoor Lighting Ordinance.

### ARTICLE Vi.

This Ordinance shall take affect five (5) days after adoption.
