ORDINANCE #2058

**AN ORDINANCE AMENDING CHAPTER 113, FEES, ARTICLE I,
TOWNSHIP SERVICES, §113-1, DESIGNATION OF FEES, OF THE
CODE OF THE TOWNSHIP OF WYCKOFF TO ESTABLISH FEES FOR
THE MILITARY TRIBUTE BANNER PROGRAM**

WHEREAS, the Township of Wyckoff maintains a schedule of municipal fees in Chapter 113, Fees, of the Revised General Ordinances; and

WHEREAS, the Township Committee has established a Military Tribute Banner Program to honor active-duty service members and veterans within the Township; and

WHEREAS, the Township Committee finds it necessary to amend Chapter 113, Article I, §113-1 to include fees associated with the creation, replacement, and duplication of military tribute banners; and

WHEREAS, the Township Committee believes these fees are reasonable, necessary for program sustainability, and in the best interests of the Township and its residents;

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Wyckoff, County of Bergen, State of New Jersey, that:

SECTION 1. Chapter 113, Fees, Article I, Township Services, §113-1, Designation of fees, is hereby amended to include a new subsection G, to read as follows:

G. Military Tribute Banner Program Fees.

New Banner – Peak Pricing: \$160.00 per banner.

New Banner – Non-Peak Pricing: \$160.00 per banner, provided the application is approved and full payment is confirmed by March 1, 2025.

Replacement or Duplicate Banner – Peak Pricing: \$100.00 per banner.

Replacement or Duplicate Banner – Non-Peak Pricing: \$100.00 per banner.

SECTION 2. All other provisions of Chapter 113 not amended herein shall remain in full force and effect.


SECTION 3. If any portion of this Ordinance shall be deemed invalid by a court of competent jurisdiction, such decision shall not affect the validity of the remaining portions.

SECTION 4. This Ordinance shall take effect upon final passage and publication
