**ORDINANCE NO. 6-2020**

**AN ORDINANCE OF THE BOROUGH OF WYOMING, LUZERNE  
COUNTY, PENNSYLVANIA LEVYING GENERAL AND SPECIAL  
TAXES FOR THE FISCAL YEAR 2021 BY SETTING THE REAL  
ESTATE TAX MILLAGE FOR THE FISCAL YEAR 2021.**

**SECTION 1. NOW, THEREFORE, BE IT ORDANINED BY THE COUNCIL OF THE  
BOROUGH OF WYOMING** that for the purpose of defraying the expenses of the Borough of Wyoming  
for the fiscal year commencing on the first day of January, 2021, and certain other deficiencies prior  
thereto, a tax is hereby levied on all real estate within the limits of the Borough of Wyoming, Pennsylvania  
taxable according to the laws of the Commonwealth of Pennsylvania as follows:

To provide for the payment of general expenses and to provide for the various interest and as  
required by law, there is hereby levied on each thousand dollar of real estate valuation in the  
Borough of Wyoming as follows:

General Fund	3.7905	Mils	(.037905	Millage Rate)
Total	3.7905	Mils	(.037905	Millage Rate)

**SECTION 2.** All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

**SECTION 3.** If any section, clause, provision or portion of this Ordinance shall be held invalid  
or unconstitutional by any Court of competent jurisdiction, such decision shall not affect any other section,  
clause, provision or portion of this Ordinance so long as it remains legally enforceable minus the invalid  
portion. The Borough reserves the right to amend this Ordinance or any portion thereof from time to time  
as it shall deem advisable in the best interests of the promotion of the purposes and intent of this Ordinance  
and the effective administration thereof.

**SECTION 4.** This Ordinance is enacted by the Council of the Borough of Wyoming under the  
Authority of the Act of the Legislature, April 18, 2014, Act No. 37 known as the Borough Code and any  
other applicable law arising under the laws of the Commonwealth of Pennsylvania.


**SECTION 5.** The tax imposed herein is effective for the calendar year 2021.


