ORDINANCE NO. 10-15-19

AN ORDINANCE OF THE CITY OF YORKTOWN, TEXAS, AMENDING CHAPTER 1, GENERAL PROVISIONS, ARTICLE 1.03, CITY COUNCIL, SECTION 1.03.002 OF THE CODE OF ORDINANCES OF THE CITY OF YORKTOWN, TEXAS; PROVIDING FOR THE TIME AND PLACE OF REGULAR CITY COUNCIL MEETINGS; PROVIDING FOR A REPEALER CLAUSE; PROVIDING FOR A SEVERABILITY CLAUSE; PROVIDING FOR AN EFFECTIVE DATE; AND PROVIDING FOR PROPER NOTICE AND MEETING.

WHEREAS, the City of Yorktown, Texas ("City") is a General Law municipality incorporated and operating under the laws of the State of Texas; and

WHEREAS, pursuant to Texas Local Government Code § 51.001, the City Council of the City of Yorktown, Texas ("City Council") has the authority to adopt, publish, amend or repeal an ordinance that is for the good government, peace or order of the City; and

WHEREAS, pursuant to Texas Local Government Code § 22.038, the City Council has the authority to determine the time and place of their meetings; and

WHEREAS, the § 1.03.002 of the City's code of Ordinances sets out the time of the City Council's regular meetings; and

WHEREAS, the City Council desires to change the time of its regular meetings and therefore finds that it is necessary and proper for the good government, peace, and order of the City to amend § 1.03.002 of the City's code of Ordinances;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF YORKTOWN, TEXAS THAT:

I. FINDINGS OF FACT

All of the above premises are hereby found to be true and correct legislative and factual findings of the City Council, and are hereby approved and incorporated into the body of this Ordinance as if copied in their entirety.

II. AMENDMENTS

Chapter 1 General Provisions, Article 1.03 City Council, Section 1.03.002 Time of Meetings of the Code of Ordinances, City of Yorktown, Texas is hereby amended in its entirety to read as follows:

Sec. 1.03.002 Time and Place of Regular Meetings

(a) The City Council of the City of Yorktown shall have its regular meetings on the second and fourth Monday of each month, beginning at 6:00 p.m. in the Yorktown City Hall.

(b) This section shall have the effect of a resolution under section 22.038 of the Texas Local Government Code or its successor provisions.

III. EFFECTIVE DATE

This Ordinance shall be and become effective immediately upon and after its passage and publication as may be required by governing law.

IV. REPEALER

All ordinances or parts of ordinances in force when the provisions of this Ordinance become effective which are inconsistent or in conflict with the terms and provisions contained in this Ordinance are hereby repealed only to the extent of such conflict.

V. SEVERABILITY

Should any part, sentence or phrase of this Ordinance be determined to be unlawful, void or unenforceable, the validity of the remaining portions of this Ordinance shall not be adversely affected. No portion of this Ordinance shall fail or become inoperative by reason of the invalidity of any other part. All provisions of this Ordinance are declared to be severable.

VI. PROPER NOTICE AND MEETING

It is hereby officially found and determined that the meeting at which this Ordinance was adopted was open to the public and that public notice of the time, place and purpose of said meeting was given as required by the Open Meetings Act, Chapter 551 of the Texas Government Code.
