**BOROUGH OF MADISON
SCHEDULE OF RATES FOR ELECTRIC UTILITY
SERVICE CLASSIFICATION RS -- RESIDENTIAL SERVICE**

Applicable to use of service for: Individual residential dwelling units and associated incidental nonresidential use and separately metered auxiliary residential use.

Character of service: Single or three-phase service at secondary voltages.

Rate per month:

Customer charge: \$4.86

Energy charge: 0 to 600 kWh \$0.1929

601 kWh or higher \$0.2039

Minimum charge per month: Monthly bills computed under this service classification shall not be rendered for less than the sum of the customer charge, plus applicable additional extension, special facilities, or supplemental customer charges.

Term of contract: None, except that reasonable notice of discontinuance will be required.

MADISON CODE

Standard terms and conditions: This service classification is subject to the standard terms and conditions of this tariff for electric service.

Special provisions: Off-peak water-heating service rider is available under this classification only for customers presently having this service.

**BOROUGH OF MADISON
SCHEDULE OF RATES FOR ELECTRIC UTILITY
SERVICE CLASSIFICATIONS GSS -- GENERAL SERVICE
(NON-DEMAND)**

Applicable to use of service for: Nonresidential general service purposes at secondary voltage where total consumption does not exceed 2,000 kWh for three consecutive months.

Character of service: Single or three-phase service at secondary voltages.

Rate per month:

Customer charge: \$4.97

Energy charge: \$0.2091 per kWh

Minimum charge per month: Monthly bills computed under this service classification shall not be rendered for less than the sum of the customer charge; plus applicable additional extension, special facilities, or supplemental customer charges.

Term of contract: None, except that reasonable notice of discontinuance will be required.

Special provisions: Where the consumption for three consecutive months exceeds 2,000 kWh, the customer will be transferred to rate classification GS.

Off-peak water heating: Off-peak water-heating rider is available under this classification only for customers presently having this service.

**BOROUGH OF MADISON
SCHEDULE OF RATES FOR ELECTRIC UTILITY
SERVICE CLASSIFICATION GS -- GENERAL SERVICE
(DEMAND)**

Applicable to use of service for: Nonresidential general service purposes at secondary voltage where total consumption exceeds 2,000 kWh for three consecutive months.

Character of service: Single or three-phase service at secondary voltages.

Rate per month:

Customer charge: \$9.75

Demand charge: \$11.273 per kW

Energy charge: \$0.1459 per kWh

Minimum charge per month: Monthly bills computed under this service classification shall be rendered for the higher of the following: the customer charge plus the demand charges registered in the current month plus the KWH charges in the current month, or the customer charge plus the demand charges for the highest demand established in the preceding 11 months.

Determination of demand: The maximum fifteen-minute integrated kilowatt demand during each billing month calculated to the nearest 1/10 kW.

Term of contract: None, except that reasonable notice of discontinuance will be required.

Special provisions: Multitype service: For utility operating reasons, or for other sufficient reason, the utility may permit both single and three-phase service to be supplied to a customer's premises under this service classification and separately metered, provided that not more than one service of each type will be permitted. Both such services must be included in the contract for service under this service classification.

Where the measured total consumption does not exceed 2,000 kWh per month for a period of 12 consecutive months, the demand meter

may be removed and the customer transferred to rate classification GSS. Off-peak water heating: Off-peak water heating-rider is available under this classification only for customers presently having this service.

SERVICE CLASSIFICATION GS-ML MID LEVEL
GENERAL SERVICE -- DEMAND**

Applicable to use of service for: Installations with billing demand of 600 kW per month and over for 12 consecutive months.

Character of service: Continuous three-phase service at primary voltage. (For service at secondary voltage, 5% will be added to the customer's monthly bill.)

Rate per month:

Customer charge: \$29.21

Demand charge: \$13.314 per kW

Energy charge: \$0.1176 per kWh

Minimum charge per month: Monthly bills computed under this service classification shall be rendered for the higher of the following: the customer charge plus the demand charges registered in the current month plus the KWH charges in the current month, or the customer charge plus the demand charges for the highest demand established in the preceding 11 months.

Determination of demand: The maximum fifteen-minute integrated kilowatt demand during each billing month calculated to the nearest 1/10 kW.

Term of contract: None, except that reasonable notice of discontinuance will be required.

Special provisions: None, except as specified in service contract.

**BOROUGH OF MADISON
SCHEDULE OF RATES FOR ELECTRIC UTILITY
SERVICE CLASSIFICATION GSL-D LARGE
GENERAL SERVICE -- DEMAND**

Applicable to use of service for: Installations with billing demand of 2,000 kW per month and over for 12 consecutive months.

Character of service: Continuous three-phase service at primary voltage. (For service at secondary voltage, 5% will be added to the customer's monthly bill.)

Rate per month:

Customer charge: \$29.21

Demand charge: \$12.764 per kW

Energy charge: \$0.1129 per kWh

Minimum charge per month: Monthly bills computed under this service classification shall be rendered for the higher of the following: the customer charge plus the demand charges registered in the current month plus the KWH charges in the current month, or the customer charge plus the demand charges for the highest demand established in the preceding 11 months.

Determination of demand: The maximum fifteen-minute integrated kilowatt demand during each billing month calculated to the nearest 1/10 kW.

Term of contract: Contracts will be based on the terms and conditions specified by the utility. Length of the contract will be concurrent with the Borough of Madison's contract for wholesale purchased power.

Special provisions: None, except as specified in service contract.

**BOROUGH OF MADISON
SCHEDULE OF RATES FOR ELECTRIC UTILITY
SERVICE CLASSIFICATION OL -- OUTDOOR AREA
LIGHT SERVICE**

Applicable to use for service for: Outdoor area lighting service operating on a standard illumination schedule of approximately 4,000 hours per year, and installed on existing wood distribution poles. This service is not available for the lighting of public streets and highways. This service is also not available where, having been installed, it is objectionable to others. This service is available only for customers presently having this service.

Character of service: Limited period (dusk to dawn) at secondary voltage.

Rate per month:

\$11.581 per 3,650 lumen mercury vapor lamp

\$17.64 per 7,000 lumen mercury vapor lamp

Term of contract: Two years for each installation and thereafter on a monthly basis.

Facilities:

(a) Standard facilities: Fixtures, lamps controls, poles, hardware, conductors, and other appurtenances necessary for service under this service classification shall be owned and maintained by the utility. Should the customer desire that the utility relocate its area lighting facilities at any time, the relocation expense shall be paid by the customer.

(b) Additional facilities: Specific additional facilities required to be furnished by the utility for service under this service classification will be rendered at the following monthly charges until such time as those facilities are no longer utilized exclusively for service under this service classification.

(1) For each span of wire: \$0.850.

(2) For each transformer: \$3.827.

(3) For each pole: \$1.106.

(c) Maintenance of facilities: Maintenance of facilities furnished by the utility under this service classification shall be scheduled during the utility's regular business hours upon notification by the customer of the need for such service. Maintenance of facilities at times other than during the utility's regular business hours shall be performed at the expense of the customer. Permission shall be given to the utility to enter the customer's premises for the purpose of inspecting and maintaining its equipment.

Standard terms and conditions: This service classification is subject to the standard terms and conditions of this tariff for electric service.

**BOROUGH OF MADISON
SCHEDULE OF RATES FOR ELECTRIC UTILITY
OFF-PEAK WATER-HEATING SERVICE RIDER -- (OPW)**

Available to use of service for: Off-peak water-heating service, residential, and general service customers using automatic storage-type water heaters for the supply of hot-water requirements of the premises where such water heaters comply with and are installed in accordance with the utility specifications. This service is available only for customers presently having this service.

Rate per month:

Customer charge: \$1.70

Energy charge: \$0.1112 per kWh

Basis of billing:

(a) The utility will furnish, install, regulate, and maintain a time switch to limit the house use of the lower heating unit. Service to the lower heating unit shall be available only during the off-peak hours. The utility shall have the right at any time to change the hours during which service to the lower heating units is available subject only to the limitation that not less than 12 hours per day will be available. Initially, the off-peak hours shall be 9:00 p.m. to 9:00 a.m. daily. The heating units

shall be supplied through separate circuits used solely for the water heater service.

(b) Energy utilized for this service during off-peak hours shall be measured by a separate meter and shall not be included in the kilowatt-hours of energy billed under the service classification applicable to the balance of the customer's service.

**BOROUGH OF MADISON
SCHEDULE OF RATES FOR ELECTRIC UTILITY
STANDBY FACILITIES SERVICE RIDER**

Applicable to use in: Available at the sole discretion of the utility, where, by special arrangement with the utility, a customer requests duplicate or standby facilities in connection with the delivery of electrical service to the customer's premises.

Character of service: To be determined by the utility and customer by special arrangement.

Rate per month:

\$1.278 per kWh of standby facilities

Definition of standby facilities: Where the service supplied by the utility, which shall include all service furnished to the customer at any one location, is available in the event of failure of the customer's private plant service or any other source of electric service or motive power, or where the service in effect serves to relive or otherwise sustain the effective operation of any other source of power, or where otherwise service requested by the customer, such service shall constitute standby service and will be furnished in conjunction with rate schedules GS or GSL.

**BOROUGH OF MADISON
SCHEDULE OF RATES FOR CUSTOMERS WHO
GENERATE AND FEED ELECTRICITY INTO
MADISON'S ELECTRICAL SYSTEM**

Applicable to service classification RS – Residential Service:

ELECTRIC UTILITY

- A. An electric customer who obtains a permit from the Borough for installation of a system to generate and feed electricity to Madison's electrical system pursuant to § 94-3 above, and, in accordance with the Rules and Regulations of the Electric Utility Department of the Borough of Madison, shall pay for energy delivered at the same rate as others in the same customer class.
- B. The Madison Borough Electric Department will:
 - 1. Credit the self-generation customer for energy the Borough receives at the then-current energy rate charged for 0 to 600 kWh for Classification RS – Residential Service. This credit will be applied against the next monthly bill. If the credit amount is greater than the bill, the remaining credit will be carried forward.
 - 2. Pay the customer for credit held at the end of the twelve-payment cycle (January through December) at the current purchase power rate, leaving no outstanding balance. The Borough shall make this payment no later than January 31 of the following year.

Applicable to other service classifications

- C. An electric customer who obtains a permit from the Borough for installation of a system to generate and feed electricity to Madison's electrical system pursuant to § 94-3 above, and, in accordance with the Rules and Regulations of the Electric Utility Department of the Borough of Madison, shall pay for energy delivered at the same rate as others and the same customer class.
- D. The Madison Borough Electric Department will:
 - 1. Credit the self-generation customer for energy the Borough receives at the same kWh rate Madison pays for purchased power. This credit will be applied against the next monthly bill. If the credit amount is greater than the bill, the remaining credit will be carried forward.
 - 2. Pay the customer for credit held at the end of the twelve-payment cycle (January through December) at the current

purchase power rate, leaving no outstanding balance. The Borough shall make this payment no later than January 31 of the following year.
