Res. 1983-6	6-6-1983	Authorizing the Borough to participate in the Pennsylvania Local Government Bond Pool, for construction of curbs and sidewalks along a portion of Manor Drive
1985-2	5-6-1985	Authorizing issuance of a series of general obligation bonds, series of 1985, in the aggregate principal amount of \$1,030,000
