2	10-3-1932	Granting franchises to Bell Telephone Company of Pennsylvania to construct and maintain the facilities over and under Borough streets that are necessary for providing services to Borough residents
4	12-5-1932	Providing for the furnishing of electric streetlighting service to the Borough of Millersville
19	5-1-1939	Providing for the furnishing of overhead electric streetlighting service to the Borough
21	6-5-1939	Granting the overhead streetlighting contract to Pennsylvania Power and Light Company for a period of five years
22	6-5-1939	Granting a franchise to Pennsylvania Power and Light Company and its successors to construct and maintain those facilities necessary to provide electricity to residents of the Borough
37	4-3-1944	Entering into a contract with Pennsylvania Power and Light to provide streetlighting services to the Borough
48	3-7-1949	Entering into a five-year contract with Pennsylvania Power and Light to provide streetlighting services to the Borough
61	4-5-1954	Entering into a contract with Pennsylvania Power and Light Company to provide electric streetlighting service to the Borough
Res. 6-7-1956		Granting Bell Telephone Company a right-of-way along Council chamber and pumping station premises for installation of underground conduits
81	10-7-1957	Granting a franchise to United Gas Improvement Company to construct and maintain the facilities necessary for supplying gas to businesses and residents of the Borough for a period of 60 years
Res. 1965-12	10-4-1965	Authorizing a contract with Pennsylvania Power and Light Company for the furnishing of electrical energy for the Borough's sewage treatment plant
Res. 1974-13	11/4/1974	Granting Pennsylvania Power and Light Company to construct, operate and maintain its electric line facilities on certain property within the Borough.

Res. 1981-2	3/2/1981	Authorizing the Borough to enter into a new agreement with Pennsylvania Power and Light Company to purchase land from the Borough and establish the right-of-way line.
Res. 1989-3	4/13/1989	Entering into a contract with Pennsylvania Power and Light Company to furnish electric street lighting to the Borough.
1991-5	6/13/1991	Amendment to the cable television franchise agreement.
Res. 1994-5	5/24/1994	Entering into a contract with Pennsylvania Power and Light Company to furnish electric street lighting to the Borough.
Res. 1994-9	8/23/1994	Authorizing the Pennsylvania Power and Light Company to furnish electric street lighting to the Borough.
Res. 1996-6	8/27/1996	Granting unto the Pennsylvania Power and Light Company, its successors, assigns and lessees, the right, privilege and authority to construct, reconstruct, maintain and operate its electric facilities comprising of one (1) pole and overhead facilities.
