1981-11	12-14-1981	Authorizing the Borough to purchase professional services related to the acquisition and installation of data processing equipment
1982-4	3-1-1982	Authorizing the Borough to enter a contract with the firm or individual submitting the low bid for the purchase of a softball/handball backstop for Freedom Memorial Park
1982-5	3-1-1982	Authorizing the officers and employees of the Borough to execute a contract with the firm or individual submitting the low bid for the grading work to be done in Freedom Memorial Park
1982-8	4-5-1982	Authorizing the officers and employees to execute contracts with the firms or individuals submitting the low bids for road materials
1982-13	5-3-1982	Authorizing the officers and employees to execute a contract with the firm or individual submitting the lowest responsible bid for the purchase of a new police car
1982-15	5-3-1982	Authorizing the officers and employees to execute contracts with NCR Corporation and Commonwealth Systems for the purchase of a computer system
