BILL NO. 1929 ORDINANCE NO. 159 a

AN ORDINANCE DECLARING IT UNLAWFUL TO OPERATE MOTOR
VEHICLES WITHIN THE CITY OF BRENTWOOD WITHOUT A LICENSE; PROVIDING
FOR A LICENSE FEE; FIXING THE LICENSE PERIOD; PROVIDING PUNISHMENT
FOR VIOLATIONS OF THIS ORDINANCE; SPECIFYING THE USE TO WHICH THE
LICENSE FEE SHALL BE PUT; AND REPEALING ALL ORDINANCES OR PARTS OF
CRDINANCES IN CONFLICT WITH THIS ORDINANCE.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF BRENTWOOD, MISSOURI, AS FOLLOWS:

Section 1

Hereafter it shall be unlawful to operate any motor driven vehicle upon a public thoroughfare within the City of Brentwood unless the owner thereof shall have first procured a license so to do from the City Clerk and paid the annual license fee, as provided in this ordinance.

Section 2

The owner of any motor driven vehicle desiring to operate the same upon or over any public highway of the City of Brentwood shall first apply to the City Clerk for a license so to do and shall pay a license fee, a sum equal to one-third of the registration fees imposed by the State of Missouri in Section 7762, Revised Statutes of Missouri, 1929, provided, however, that the license fee for each vehicle designed to be used for private passenger use shall not exceed the sum of Three Dollars, and that each license fee for each vehicle designed to be used as a truck, or for delivery purposes, or for the hauling of passengers for hire, shall not exceed the sum of Five Dollars, each such license shall be issued for a term of one year beginning on the first day of July and ending with the last day of July and in the last day of July and i

Section 3

The license fees provided for in this ordinance shall be payable to the City Treasurer, held by the Treasurer in a separate fund and used from time to time and pursuant to directions of the Board of Aldermen of said City, solely for the purpose of oiling of public streets and the making of minor repairs of public streets. Section 4

Every person convicted of violation of this ordinance shall be punished by fine of not less than Five Dollars nor more than Fifty Dollars or by imprisonment in the City Jail for not less than five days nor more than thirty days or by both such fine and imprisonment. Section 5

All license tags issued in pursuance of this ordinance shall be displayed at all times in a conspicuous place upon the front end of the vehicle for which the license tag is issued.

Section 6

All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed.
