

AN ORDINANCE PROVIDING FOR THE RELOCATION OF ONE FIRE HYDRANT IN THE CITY OF BRENTWOOD, MISSOURI.

Be It Ordained By The Board of Aldermen of the City of Brentwood, Missouri, as follows:

SECTION 1. St. Louis County Water Company shall, in accordance with the terms and provisions of Contract Ordinance No. 1539 between the City of Brentwood, Missouri and St. Louis County Water Company, relocate one fire hydrant in the City of Brentwood at the following location, to-wit:

2348 Brentwood Boulevard, Brentwood, Missouri,

Move present hydrant up to 16 feet to the West on City property.

SECTION 2. Said work of relocation shall be done under the supervision of the Board of Aldermen or its designated representative, and, for the purpose of this ordinance, the St. Louis County Water Company is hereby given permission to make such excavation as may be necessary for the proper execution of the work.

SECTION 3. The charge on said hydrant shall be paid at the established rate commencing the date the hydrant is installed, supplied with water and in working order.


SECTION 4. The City Clerk-Administrator is hereby authorized and directed to furnish a duly authenticated copy hereof to St. Louis County Water Company.

SECTION 5. This ordinance shall be in full force and effect from and after the date of its passage and approval according to law.



AN ORDINANCE AUTHORIZING AND DIRECTING THE MAYOR OF THE CITY OF BRENTWOOD, TO SIGN A SUPPLEMENTAL CONTRACT WITH ST. LOUIS COUNTY, MISSOURI, FOR THE COLLECTION AND DISTRIBUTION OF ANNUAL FEES FOR RESTAURANT AND SWIMMING POOL PERMITS.

WHEREAS, the City of Brentwood, under the authorization provided by Ordinance 2117, has entered into a contract, date January 21, 1974, with St. Louis County, Missouri for the furnishing of Public Health Services by St. Louis County to the City of Brentwood, and

WHEREAS, the increase in cost and time necessary for the proper inspection of restaurants and swimming pools necessitates the charging of permit fee for such establishments; and

WHEREAS, the City of Brentwood has by ordinance authorized the collection of annual inspection permit fees from restaurants and swimming pools;

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR OF THE CITY OF BRENTWOOD, ST. LOUIS COUNTY, MISSOURI, AS FOLLOWS:

SECTION 1. The Mayor of the City of Brentwood is authorized and directed to sign, on behalf of the City of Brentwood, a supplemental contract which shall provide for the collection by the Director of Health of St. Louis County of an annual permit fee for restaurants in the amount of \$30.00 and for swimming pools in the amount of \$150.00.


SECTION 2. Said supplemental contract shall provide for the distribution of said permit fees on the basis of one-third (1/3) to the City of Brentwood and two-thirds (2/3) to St. Louis County within thirty (30) days following the close of the calendar year in which such fees were collected.


SECTION 3. This Ordinance shall take effect and be in full force from and after its passage and approval.
