

AN ORDINANCE RELATING TO PERSONAL TAX REFUNDS RECEIVED AS PAYMENT OF THE 1974 TAXES, ORDERED TO BE REFUNDED FROM THE COLLECTORS ACCOUNT AS A SUPPLEMENTAL ACTION AS REQUESTED BY THE ACTION OF THE ST. LOUIS COUNTY TAX COLLECTOR.

Be It Ordained By The Board of Aldermen of the City of Brentwood, Missouri, as follows:

SECTION 1. The personal tax refund received as payment of the 1974 taxes are ordered to be refunded from the Collectors Account as a supplemental action as requested by the action of the St. Louis County Tax Collector.

SECTION 2. The Personal Tax Refunds referred to in Section 1 hereof are in the amount and for the persons set forth on the one page list attached hereto and made a part hereof as fully set forth herein. The amount of said Personal Property Refunds is in the aggregate sum of Eight Hundred and Fifty Six Dollars and Fifty Seven Cents (\$856.57).

SECTION 3. The City Collector is hereby authorized and directed to issue for payment such Personal Tax Refunds from the Collectors Account of the City of Brentwood.


SECTION 4. This ordinance shall be in full force and effect from and after the date of its passage and approval according to law.
