

AN ORDINANCE RELATING TO THE DELINQUENT TAXES FOR THE YEAR 1973 NOT HERETOFORE COLLECTED, AND AUTHORIZING THE COLLECTOR TO STRIKE SUCH DELINQUENT REAL ESTATE TAXES FROM THE CITY RECORDS AND TO TAKE CREDIT THEREFOR.

Be It Ordained By The Board of Aldermen of the City of Brentwood, Missouri, as follows:

SECTION 1. The Delinquent Real Estate Taxes for the year 1973 not heretofore collected are ordered stricken from the Tax Books of the City of Brentwood, Missouri on account of statutory limitations.

SECTION 2. The Delinquent Taxes referred to in Section 1 hereof are in the amount and from the persons set forth on the one page list attached hereto and made a part hereof as fully set forth herein. The amount of said Delinquent Taxes is in the aggregate sum of fifteen dollars and fifty eight cents (\$15.58).


SECTION 3. The City Collector is hereby authorized and directed to strike such Delinquent Real Estate Taxes from the City Tax Records and to take credit therefor.

SECTION 4. This Ordinance shall be in full force and effect from and after the date of its passage and approval according to law.
