

**ORDINANCE 2014-1**

**AN ORDINANCE OF THE BOROUGH OF CHESTER, MORRIS COUNTY, STATE OF NEW JERSEY, AMENDING ARTICLE I, "MUNICIPAL FEES" OF CHAPTER 127, "FEES," OF THE CODE OF THE BOROUGH OF CHESTER**

**WHEREAS**, municipalities are empowered to make, amend, repeal, and enforce its ordinances pursuant to Statute (N.J.S.A. 40:48-1, et seq.); and

**WHEREAS**, municipalities are required by Statute to follow specific procedures for the passage of ordinances (N.J.S.A. 40:49-2 et seq.); and

**WHEREAS**, Chapter 127 (Fees), Article I (Municipal Fees) lists certain fees established and charged by the Borough of Chester, for various services, as provided by the applicable municipal ordinance governing said services; and

**WHEREAS**, the Mayor and Borough Council wish to amend the fees charged for an event at the Grove Street Field House; and

**NOW, THEREFORE, BE IT ORDAINED**, by the Council of the Borough of Chester, County of Morris, State of New Jersey that the Borough Code is hereby amended as follows:

**SECTION 1:** §127-1 of the Code of the Borough of Chester is hereby amended as follows:

<u>Chapter</u>	<u>Section</u>	<u>Description</u>	<u>Amount</u>
Ch. 9	11	Field House Event (for use by profit groups; private individual or family use; and community groups)	\$325.00 (for up to 4 hours)  \$65.00 per hour after 4 hours (60 minutes or any part thereof = 1 hour)

**SECTION 2. Severability.** Each section, subsection, sentence, clause and phrase of this Ordinance is declared to be an independent section, subsection, sentence, clause and phrase, and the finding or holding of any such portion of this Ordinance to be unconstitutional, void, or ineffective for any cause, or reason, shall not affect any other portion of this Ordinance.

**SECTION 3. Repealer.** All ordinances or rules or regulations of the Borough of Chester, which are inconsistent with the provisions of this ordinance, are hereby repealed to the extent of such inconsistency.

**SECTION 4. Effective Date.** This ordinance shall take effect upon passage and publication according to law.
