

ORDINANCE 2014 -3

AN ORDINANCE OF THE BOROUGH OF CHESTER, MORRIS COUNTY, STATE OF NEW JERSEY, AMENDING ARTICLE I, "MUNICIPAL FEES" OF CHAPTER 127, "FEES," OF THE CODE OF THE BOROUGH OF CHESTER FOR SPECIAL EVENTS.

WHEREAS, municipalities are empowered to make, amend, repeal, and enforce its ordinances pursuant to Statute (N.J.S.A. 40:48-1, et seq.); and

WHEREAS, municipalities are required by Statute to follow specific procedures for the passage of ordinances (N.J.S.A. 40:49-2 et seq.); and

WHEREAS, Chapter 127 (Fees), Article I (Municipal Fees) lists certain fees established and charged by the Borough of Chester, for various services rendered, as provided by the applicable municipal ordinance governing said services; and

WHEREAS, the Mayor and Borough Council wish to add, amend or remove certain fees and or amounts as same relate to fees charged for various services rendered, provided by the Borough of Chester; and

NOW, THEREFORE, BE IT ORDAINED, by the Council of the Borough of Chester, County of Morris, State of New Jersey that the Borough Code is hereby amended as follows:

SECTION 1: §127-1 of the Code of the Borough of Chester is hereby amended as follows:

203	7	Special Event Proprietor's license fee per calendar year ¹	First event (per year) = \$0.00 Each subsequent event (per year) = \$100.00
203	7	Market Proprietor's license fee per calendar year ²	1 Concessionaire = \$5.00 per day 2-15 Concessionaires = \$10.00 per day 16 or more Concessionaires = \$25.00 per day

SECTION 2. Severability. Each section, subsection, sentence, clause and phrase of this Ordinance is declared to be an independent section, subsection, sentence, clause and phrase, and the finding or holding of any such portion of this Ordinance to be unconstitutional, void, or ineffective for any cause, or reason, shall not affect any other portion of this Ordinance.

SECTION 3. Repealer. All ordinances or rules or regulations of the Borough of Chester, which are inconsistent with the provisions of this ordinance, are hereby repealed to the extent of such inconsistency.

SECTION 4. Effective Date. This ordinance shall take effect upon passage and publication according to law.
