1. Discussion and Motion to approve Ordinance No. 549; which amends Ordinance No. 344; to delete the requirement that the Secretary/Manger be a resident of Crescent Township and in lieu thereof substitute a requirement that the Secretary/Manager be a resident of the Moon Area School District
