Motion to approve the Advertisement of Ordinance 541 which, if adopted, would set the tax revenue for 2013 at \$833,437.00 (Which is currently estimated at 6.4 mills) was made by Commissioner Patton and seconded by Commissioner Keller. A roll call vote was taken and found all Commissioners in favor of the motion.

Motion to Approve the Advertisement of Ordinance 542 which, if adopted, would appropriate fund equities, revenues and other financing sources available for the year 2013 at \$833,437 (Which is currently estimated at 6.4 mills) was made by Commissioner Keller and seconded by

Commissioner Patton. A roll call vote was taken and all Commissioners were in favor of the motion.

### **NEW BUSINESS**

A motion to approve the transfer of \$50,000.00 from the General Fund from line item 430.600 into a special fund account for use on the McCutcheon Way Slide Repair was made by Commissioner Patton and seconded by Commissioner Keller. A roll call vote was taken and all Commissioners were in favor of the motion.
