The monthly meeting of the Crescent Township Board of Commissioners was called to order at 6:30 P.M. Via telephone Zoom.

APPROVAL OF MINUTES

Commissioner Sabol asked for a motion to approve the September 10, 2020 business meeting minutes. A motion was made by Commissioner Keller and seconded by Commissioner Withee. A roll call vote was taken and found all commissioners in favor of the motion.

Commissioner Sabol asked for a motion to approve the September 2020 Treasurer's report. Commissioner Miller made a motion and was seconded by Commissioner Withee. A roll call vote was taken and found all commissioners in favor of the motion.

BILLS TO BE PAID

Commissioner Sabol asked for a motion for the approval of the bill for October 2020 and any other bills that may be forthcoming in the month of October 2020. A motion to pay the bills was made by Commissioner Keller and seconded by Commissioner Buccigrossi. A roll call vote was taken and found all Commissioners in favor of the motion.

Commissioner Withee made a motion and was seconded by Commissioner Miller. A roll call vote was taken and found all commissioners in favor of the motion.

OLD BUSINESS

One item under old business was a motion to approve Ordinance # 579 for the placement of a stop sign at the intersection of Keim St. and Cherry Alley, changing Chapter 830 Sections 830.02. Commissioner Miller made the motion Seconded by Commissioner Buccigrossi. A roll call was taken and all commissioners were in favor.

NEW BUSINESS

The first item under new business was a motion to accept Resolution R-10-2020 the PennDOT Winter Maintenance Agreement. This agreement will be valid for 5 years. Commissioner Miller made the motion Seconded by Commissioner Keller. A roll call was taken and all commissioners were in favor.

The second item under new business was a motion to approve Resolution R-11-2020 for Plan Revision for New Land Development for Premier Pan Company, Inc., the proposed development identified as Premier Pan Warehouse for sewer tap-ins, sewer extension, and a private pump station and force main. Commissioner Keller made the motion Seconded by Commissioner Withee. A roll call was taken and all commissioners were in favor.

The third item under new business was a motion to terminate the professional services of HMT and Associates as the Township Consulting Engineer, effective immediately but that their professional services as Code Enforcement Officer be retained. Commissioner Keller made the motion Seconded by Commissioner Buccigrossi. A roll call was taken and all commissioners were in favor.

The fourth item under new business was a motion to appoint Lennon, Smith, Souleret Engineering as Consulting Engineer to the Township, effective immediately. Commissioner Miller made the motion Seconded by Commissioner Keller. A roll call was taken and all commissioners were in favor.

The fifth item under new business motion to exercise and accept the option to extend the Option Year Two (January 1, 2021 to December 31, 2021) with Republic Services with Add Alternates Numbers #1, #2 and #3. Commissioner Keller made the motion Seconded by Commissioner Withee. Commissioner Buccigrossi abstained from the vote. A roll call was taken and all commissioners were in favor.
