The first item under new business was a motion/discussion for the approval of roads in Crescent Township to be submitted to Moon Township's Road Program to piggy back with Moon. The second item under new business was a motion/discussion to revise the Burning Ordinance for the Township. A legal advertisement will be place in the paper. Commissioner Withee made the motion Seconded by Commissioner Keller. A roll call was taken and all commissioners were in favor.

The third item under new business was a motion to exonerate the Tax Collector Judy Withee for the uncollected real estate taxes for the year 2020 in the amount of \$39,687.88. This amount has been turned over to the Townships Delinquent Tax Collectors, Weiss Burkhardt & Kramer. The amount of \$15,139.21 for the Townships Delinquent Garbage collection has been turned over to Jordan Tax Services. Commissioner Keller made the motion Seconded by Commissioner Miller. Commissioner Withee abstained from the vote. A roll call was taken and all of the other commissioners were in favor.

The fourth item under new business was a motion/discussion to authorize the advertisement of amending Ordinance #299 correcting a clerical error to replace with Ordinance #582, now to state Marble Street to Marble Drive. Commissioner Miller made the motion Seconded by Commissioner Keller. A roll call was taken and all commissioners were in favor.
