E. ORDINANCES: FOR FINAL PASSAGE

1. Council File No. 15,985 Pending Official File Ordinance 10-2017

An ordinance renewing **Erie Downtown Improvement District (EDID)** for the area shown on Exhibit “A” at the request of the Erie Downtown Partnership: An Improvement District Association and a coalition of property owners, business leaders, retailers and local government and institutional representatives as provided by the Neighborhood Improvement District Act of 2000.

2. Council File No. 15,986 Pending Official File Ordinance 11-2017

An ordinance appropriating the sum of \$15,000.00 from unappropriated revenue for the expenditure thereof (contribution is from the **Sisters of Mercy** for the purpose of police equipment, fire prevention supplies or equipment and winter maintenance equipment).

3. Council File No. 15,987 Pending Official File Ordinance 12-2017

An ordinance requiring all persons, partnerships, businesses and corporations to obtain a permit for any construction or development; providing for the issuance of such permits; setting forth certain minimum requirements for new construction and development within areas of the **City of Erie** which are subject to **flooding**; and establishing penalties for any persons who fail, or refuse to comply with, the requirements or provisions of this ordinance.
