Attachment to 2014 Minimum Municipal Obligation to be presented to City Council

The Minimum Municipal Obligation for the pension plans of the City of Erie is being certified with City Council. This procedure is required under Act 205 which pertains to the funding requirements of State Regulated Employee Retirement Programs.

The 2014 Minimum Municipal Obligation, including \$251,218 for the portion paid by the Erie City Water Authority, totals \$10,164,351. The City of Erie portion of the 2014 Minimum Municipal Obligation is \$74,935 more than the 2013 Minimum Municipal Obligation. The increase is the result of increases in payroll compared to last year

In order to certify the Minimum Municipal Obligation timely, we used the January 1, 2011 actuarial valuation report to prepare the 2014 Minimum Municipal Obligation. This is the last actuarial valuation report completed for the Plan and it is acceptable to use this valuation at this time.
