STEPHEN A. FENTON

WHEREAS, Stephen A. Fenton of Verona, New Jersey, is being remembered upon his passing from this life on Sunday, April 19, 2020, at the age of 77; and

WHEREAS, Stephen A. Fenton was born on February 7, 1943, and raised in Glen Ridge, New Jersey, and moved to Verona in 1965. He also enjoyed time in Edgecomb, Maine; and

WHEREAS, Stephen A. Fenton was the owner of Fenton Contracting of Verona from 1965 to 2005 and was often seen driving his trucks and front end loaders along the streets of West Essex; and

WHEREAS, Stephen A. Fenton was active in the community and served in the Verona Kiwanis, as Vice President, he was a member of the Verona Fire Department (Company 2) from 1967 to 1974, and was on the Verona Rescue Squad from 1968 to 1980, serving as Captain. He also was a member of the Edgecomb, Maine, Fire Department, serving as Equipment Captain. He was known to often say "Nothing is impossible, the impossible just may take a little longer"; and

WHEREAS, Stephen A. Fenton is survived by his beloved wife Phyllis (nee Poch) Fenton; her children, John Martin, Alice McCarthy, Nancy Martin, Daniel Martin and Joel Martin; 9 grandchildren; one great grandchild; and a host of extended family and friends; now, therefore, be it
