**ORDINANCE NO. 14-24**

**AN ORDINANCE CHANGING THE NAME OF PART OF SAM WEINROTH ROAD NEAR TRENTON-MERCER AIRPORT TO AIRPORT CORPORATE DRIVE**

**WHEREAS**, the Township deems the promotion of the Trenton-Mercer Airport to be in the public interest; and

**WHEREAS**, the Township desires to facilitate rebranding efforts of the area surrounding the Trenton-Mercer Airport; and

**WHEREAS**, as part of the rebranding effort, the Township desires to change the name of Sam Weinroth Road east of West Piper Avenue to Airport Corporate Drive.

**WHEREAS**, the Township has the authority to change street names within its boundaries.

**NOW THEREFORE, BE IT ORDAINED**, by the Township Council of the Township of Ewing that Sam Weinroth Road east of West Piper Avenue shall be renamed Airport Corporate Drive.

**BE IT FURTHER ORDAINED**, that the Township is authorized to take all necessary actions to effectuate the said street name change.

**BE IT FURTHER ORDAINED**, that this Ordinance shall take effect upon final passage and publication according to law.

STATEMENT

This Ordinance changes the name of Sam Weinroth Road east of West Piper Avenue to Airport Corporate Drive.
