

**REORGANIZATION MEETING**

**January 1, 2016**

**2:00 p.m.**

The Clerk of Ewing called the meeting to order at 2:00 p.m. Before introducing the Master of Ceremonies, Mr. Charlie Geter, she wished everyone a happy, healthy and prosperous New Year. She then welcomed Mr. Charlie Geter, former radio personality in Philadelphia and Trenton, a member of Ewing Lawrence Sewerage Authority and community activist to the podium for welcoming and opening remarks.

Mr. Geter commented that the Clerk said that very well and he would see that she gets a raise (Laughter). He said he just saw the Mayor flinch and also the Business Administrator (Laughter).

He further went on to say that it was a pleasure seeing everyone and he welcomed everyone. He said today we are here for the reorganization and it gives him great pleasure to introduce a young man who has come into the Mercer County area who will give our invocation. He said this young man has made a mark in the City of Trenton and the County of Mercer and further said that he is a great friend, Pastor of Shiloh Baptist Church, Reverend Darrell Armstrong. Reverend Armstrong gave the invocation.

Mr. Geter then asked that all remain standing as he introduced the Ewing Police Honor Guard to present the colors of our Country and our Community. He led all in the Pledge of Allegiance. Mr. Geter thanked all the members of the Police Department for attending: Sgt. Daniel McGuire. Officer Robert Birchenough, Officer Edward Lester, Officer Abdelbasset Jibbou, Piper/Lt. David LaBaw and Snare/Christopher LaBaw

At this time, Mr. Geter turned over the inaugural proceedings to Clerk Kim Macellaro who will read the Open Public Meetings Statement.

The Clerk read Open Public Meetings Statement.

President Schroth introduced Mayor Steinmann for his comments

Mayor Steinmann took the opportunity to wish everyone a very Merry and Happy 2016. He said he personally is glad that 2015 is behind him. He congratulated Council President Schroth and Vice President Steward for being nominated by their peers and he knows it will be a great year and they will do a fantastic job moving forward. He further went on to say it was a great pleasure to serve and have conversations and dialogue with the former President Ms. Keyes-Maloney and her insight into what we were trying to accomplish and the questions that she asked were certainly relevant at that time and sometimes raised his eyebrow on occasions, but that is what this is all about. He said he is happy and proud and the majority of the time, we were on the same page. The vision has paid off dividends for Ewing Township in 2015. He knows the vision will be maintained in 2016. He said economic development will be at a faster pace in 2016. We are working very hard with Ewing Township Council to work on our infrastructure. The other area we are concentrating on is technology. We are making improvements to make our lives and our citizens lives a lot easier. We have been working for the last six months on a new website. We hope to be ready to launch in the next 2-3 months. He further stated that starting January 1<sup>st</sup> they are launching a new program regarding building permits, inspections, etc. He said he is looking forward to a very bright and happy 2016 and he is really looking forward to moving Ewing to where Ewing Township has never been and he is excited about the future. He thanked everyone for being there to pay their respects to Council and him. He again congratulated everyone on Council. He said that he didn't notice Congresswoman Bonnie Watson-Coleman in the audience but wanted to mention that she has been a mainstay of his for a very long time and a very great supporter of him. He said that when he went through his difficult time, she constantly called and kept him in her prayers and that meant more to him than anything else and he is forever grateful to our Congresswoman for keeping his family in her prayers during their most difficult time. He then turned it back over to President Schroth.

President Schroth thanked everyone for being there today and thanked specifically Charlie Geter for hosting this afternoon. He thanked Reverend Armstrong for being there and honoring us with his presence. He thanked Reverend Coleman, in advance (Congresswoman Bonnie-Watson Coleman's other half) for giving the benediction. He further thanked all of the public officials that were present today. He thanked his family, sister and brother-in-law, two great nieces, his Mom and his Fiancé Monica. He thanked his fellow Council members, Jennifer for her dedicated leadership as President this past year and her unwavering and unparalleled commitment to the community. He thanked Sarah, Kevin and Kathy for their dedication and he knows without exception that they will make Ewing a better place. He thanked Mayor Steinmann and said he shares in his vision for making Ewing Township a better community. He further said that the Township has improved in so many ways, it has brought stability to the Township, particularly in the area of economic development and he looked forward to working with him. He thanked the Township employees who are so dedicated and work so hard for all of us and don't get the thanks that they deserve and he said each one is deeply appreciated. He wished everyone the best in the coming year!

President Steward expressed her gratitude to everyone there today and said she is very honored to be selected as Vice President. She thanked Mercer County Clerk Paula Sollami-Covello for swearing her in today and she thanked all the community leaders who would be recognized a little later in the program. She also thanked Mayor Steinmann and her colleagues for being great teammates and making Ewing a better place. She specifically thanked outgoing President Jennifer for doing a fantastic job and incoming President Dave who she is looking forward to working with. She thanked the Township Professionals, Jim, Maeve, Kim and Joanna who provide such excellent Counsel and support to us throughout the year. For the people who serve and protect our community, Police, Fire and EMT, seen and unseen, she is very grateful for. She also thanked Township volunteers on Boards and Commissions and said that this was her first year on Green Team and it highlighted just how much work the volunteers do behind the scenes and it inspires her to do more. She thanked her family and friends for supporting her not only now but through the rest of the year. She thanked the residents of Ewing for their continued support this past year and the year to come. She further went on to say that Ewing is not only a beautiful place to live but also to work and raise a family. The things we have planned and underway are important as well as exciting. We have a great team to build our success! She looks forward this year to working with the Green Team as we are pursuing our Sustainable Jersey re-certification which means that we engage in a number of projects to enhance sustainability in the community. We are currently Bronze certified and are shooting for Silver. In all things as we track Ewing's path forward, her and her colleagues invite feedback and participation and encourage you to attend every second and fourth Tuesday night Council meeting. She finished by saying that she is humbled and honored to continue to serve the people of Ewing and will do her best in the upcoming year.

Councilwoman Keyes-Maloney thanked everyone for being with us today. She said that 2015 brought many blessings to our community. She said that a continued strength and partnership with our school and higher education communities, from the joint meeting we held with our school board to examine the growth and impact of our community, to the continued collective work with the College of New Jersey on Campus Town. We are strengthening the bonds that make our community great. We also renewed our relationship with the faith community by bringing all faiths together to share the work of the township and re-establish those critical links when disaster strikes. Our inaugural Thanksgiving gathering was but the first manifestation of that collaboration and she said she was proud to be a part of it. She further said we have a new community art space in the 1867 sanctuary that will provide a new venue for locals. She continued that we have a new dining and retail space that brings both the college community and the community as a whole in Campus Town. We invested in our infrastructure as a town this year, from road improvements to the upgrades in our first responder technology and equipment. These critical items help solidify our community. From the Green Teams inaugural bike ride to the art commissions student art show to the rec's robust summer and school year's schedules, we have a lot to be proud of in Ewing. She thanked the first responders for keeping our homes and streets safe. She thanked the public works department for keeping the parks clean. She thanked the Health Department for keeping our children, our seniors, our neighbors and our pets healthy. She thanked the Rec Department who provide programming for the young and the mature among us. She knows the difference this makes to kids and seniors, particularly in light of her father's dementia. She thanked code enforcement for keeping the places we dine, live and visit safe. She thanked the Clerk's Office, who often serves as the front line to our citizens' questions and concerns, she said your service is one of the faces of our township that is so critical and you do it so well. To the professionals who make sure we know the rules and abide by them, she thanked them. Also our volunteers who serve on any number of critical boards, who help us make decisions that affect peoples' lives. She thanked the Administrative team, from our CFO who keeps the township on a firm economic footing, to our Business Administrator for keeping the township operationally sound by successfully fielding the myriad of challenges that cross his desk and to our Mayor, who provides a firm strategic vision for our town and pushing us to grow and thrive in a time of change. She said that without your leadership our bond rating would not be as exceptional as it is and the services our citizens receive would not be as strong. To all the employees and volunteers, you make Ewing a better place to live and grow and for that she says thank you. She wished all her colleagues a successful and healthy 2016. She told President Schroth that he will do a tremendous job as President. She told Sarah that you are David's second and said she knows you will be there any time he needs you. She thanked them all for sharing their experiences, expertise and passion for Ewing. She finally said she would be remiss if she did not extend

her thanks to the citizens of Ewing who put their confidence in us to serve. She said she hopes to continue to make them proud, proud of the town we call home. She finished with a quote from John F. Kennedy as it sets the stage for the coming year – “as we express our gratitude, we must never forget that the highest appreciation is not to utter words, but to live by them”. She ended by saying may God’s providence be upon us in this coming year.

Councilwoman Wollert said that it is so great to see all of our friends, relatives, employees, committee and commission members who support this town in so many wonderful ways as we take on a new year and the challenges we all face in that new year. From all of my fellow colleagues, you have heard about all of the great things being worked on in 2016. As we do this, we will have problems and upsets, but she said she remembers two things everyday – there is nothing new under the sun, there is no problem that we face on any level that has not been faced by others who have gone before us. She said she is hopeful that we can continue to produce good results with that in mind. She said we are unique in and of this time but not so unique that we can’t apply the lessons from those who have gone before us. The second thing, in the immortal words of Scarlet O’Hara, “Tomorrow is another day”! She said that no matter how down we get, no matter how bad things may seem, tomorrow is another day! She wished everyone, from the bottom of her heart, a wonderful, healthy and prosperous year in 2016. She said that it is such a pleasure to work with this Council. She said we have great employees and a great Mayor who has done his level best to move everything possible forward and he deserves the town’s appreciation for that. She further stated that we have a great business administrator and great CFO who have gotten us back on a great financial footing. She sent her best wishes from herself and her family and wished everyone a wonderful and blessed New Year.

Councilman Baxter said that the beauty of going last is that he doesn’t have to say a whole lot, they have said it all. He wished everyone a happy and safe 2016. He is thankful that we have seen another year and all of you have come out this afternoon to honor Dave and Sarah as they take the reins of this Council. He says he knows they will do a great job and he has seen their attentiveness and diligence and we are all in good hands. He said that he remembers when they all started together and now the circle has just about gone around and Dave is in the hot seat. He said he is ready and his lovely fiancé will keep him in excellent order. He congratulated President Schroth and said he is only a call away if he needs anything and he counted on Vice President Steward to hold him up. He told them both to have their vision and know where you want to take the town and be firm and resolute. He said the Mayor barks loud, but he doesn’t bite. He said Jimmy is the biter (laughter). He said the Mayor has a great vision and is doing an awesome job even through the most difficult times. He further said that all of our professionals and employees, especially the Clerk’s office, the office that we deal with the most. He said they are really the champions because they teach us, tell us and set us straight. He looks forward to the year and appreciates Dave re-appointing him to the Recreation Board, as it is a passion of his. Working with the youth in our community is what drives him. Our children are our future. He thanked the school board members and he looks forward to working with them all. He thanked everyone once again for coming out and let them know that they are there if needed.

The Clerk turned the floor back to Charlie Geter who recognized the dignitaries.

#### **RECOGNITION OF DIGNITARIES**
