TOWNSHIP OF EWING
ORDINANCE NO. **13-11**

AN ORDINANCE AMENDING THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF EWING AMENDING THE FEES FOR AMBULANCE TRANSPORT BY EWING TOWNSHIP EMERGENCY MEDICAL SERVICES DIVISION

WHEREAS, a survey of fees charged by other New Jersey municipalities for the provision of ambulance transport services indicates that the fees charged by Ewing Township are less than the average; and

WHEREAS, it is in the best interests of the Township that a fair and equitable fee structure be adopted;

NOW THEREFORE, BE IT ORDAINED, by the Township Council of the Township of Ewing that **Chapter 100, FEES. Section 100-1(N), Schedule of Fees, Emergency Medical Services and Ambulance Transport Services Fees**, of the Code of the Township of Ewing is hereby amended as follows:

Section 1. **Chapter 100, FEES. Section 100-1(H), Schedule of Fees, Emergency Medical Services and Ambulance Transport Services Fees**, of the Code of the Township of Ewing is hereby amended as follows:

N. Emergency Medical Services and Ambulance Transport Services Fees

- (1) A fee of ~~Four Hundred Dollars and No Cents (\$400.00)~~ ~~\$600.00~~ \$700.00 plus ~~Ten Dollars and No Cents (\$10.00)~~ \$12.00 per mile calculated one way will be charged to all persons receiving emergency medical services or ambulance transport services by non-volunteer Ewing Township Emergency Medical Services. In addition to the above, a fee in the amount of ~~\$60.00~~ \$65.00 will be charged for the use of oxygen, when required.

Section 2. If any section or part of this Ordinance shall be declared invalid by the judgment of any court or competent jurisdiction, such section or part shall be deemed to be severable from the remainder of this Ordinance.

Section 3. This Ordinance shall take effect upon final passage and publication according to law.

STATEMENT

This Ordinance amends the Revised General Ordinances of the Township of Ewing amending the Fees for provision of Ambulance Services by the Ewing Township Emergency Medical Services Division.
