AN ORDINANCE OF THE TOWNSHIP OF EWING, COUNTY OF MERCER, STATE OF  
NEW JERSEY, VACATING THE STREET KNOWN AS CAMPUS COURT IN THE  
TOWNSHIP OF EWING

---

WHEREAS, pursuant to N.J.S.A. 40:67-1b, the Township Council may, by ordinance, establish, change the grade of or vacate any public street, highway, lane or alley, or any part thereof; and,

WHEREAS, pursuant to N.J.S.A. 40:67-1b, the Township Council must, by ordinance, preserve the public utilities' right to maintain, repair and replace their existing utility facilities, including cable television facilities, in, adjacent to, over, or under the property to be vacated.

NOW THEREFORE BE IT ORDAINED, by the Council of the Township of Ewing, in the County of Mercer, State of New Jersey, as follows:

1. The street known as Campus Court in the Township of Ewing, as more particularly shown on the Tax Map of the Township of Ewing, is hereby vacated, and the portions thereof divided and conveyed to the adjoining property owners 50-50 in accordance with the law;
2. All rights and privileges possessed by public utilities, as defined by R.S. 48:2-13, and by any cable television company, as defined in the "Cable Television Act," N.J.S.A. 48:5A-1 etseq., to maintain, repair and replace facilities, in, adjacent to, over or under Campus Court are hereby expressly reserved from vacation;
3. The Municipal Clerk shall publish, this ordinance, after being introduced and having passed a first reading, at least once not less than ten (10) days instead of one (1) week prior to the time fixed for further consideration for final passage, pursuant to N.J.S.A. 40:49-6;
4. The Municipal Clerk shall, at least one (1) week prior to the time fixed for final passage of such ordinance, mail a copy thereof, together with a notice of the introduction thereof, and the time and place when and where the ordinance will be further considered for final passage, to every person whose lands may be affected by the ordinance or any assessment which may be made in pursuance thereof, pursuant to N.J.S.A. 40:49-6; and,
5. The Municipal Clerk shall within sixty (60) days after such ordinance becomes effective file a certified copy of the ordinance vacating the streets along with proof of publication thereof with the office of the County Clerk in a special book set aside for vacations, pursuant to N.J.S.A. 40:67-21.

Section 1. This Ordinance shall take effect after final passage and publication according to law.

**STATEMENT**

This Ordinance vacates the street known as Campus Court located in the Township, pursuant to N.J.S.A. 40:67-1b.
