ORDINANCE NO. 15-12

AN ORDINANCE AMENDING THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF EWING IN THE COUNTY OF MERCER, TO AMEND CHAPTER 225, VEHICLES AND TRAFFIC, ARTICLE II, PARKING, TO PROHIBIT THE PARKING OF VEHICLES IN EXCESS OF FOUR TONS AT CERTAIN LOCATIONS

**WHEREAS**, the Township has determined that the parking of vehicles with a gross vehicle weight in excess of four (4) tons at the Ewing Senior and Community Center, the Hollowbrook Community Center, and Lou Lamata Soccer Fields at Rambling Creek Park is incongruous with the character and safety of these public spaces; and

**WHEREAS**, pursuant to the Township's authority to implement traffic and parking regulations, the Township desires to prohibit the parking of vehicles with a gross vehicle weight in excess of four (4) tons at the Ewing Senior and Community Center, the Hollowbrook Community Center, and Lou Lamata Soccer Fields at Rambling Creek Park, except for deliveries or Township business.

**BE IT ORDAINED** by the Council of the Township of Ewing, County of Mercer that the Code of the Township of Ewing be amended as follows:

Section 1 Chapter 225, VEHICLES AND TRAFFIC, ARTICLE II, PARKING, Section 10.4, PARKING PROHIBITED AT CERTAIN LOCATIONS, is hereby added to read as follows:

**§ 225-10.5 Parking prohibited at certain locations.**

No person shall park a vehicle in excess of four (4) tons at the Ewing Senior and Community Center, the Hollowbrook Community Center, and Lou Lamata Soccer Fields at Rambling Creek Park, except for deliveries or Township business.

Section 2 Severability. Should any section, clause, sentence, phrase or provision of this article be declared unconstitutional or invalid by a court of competent jurisdiction, such decision shall not affect the remaining portions of this article.

Section 3 Repealer. All prior ordinances or parts of same inconsistent with any provisions of this article are hereby repealed to the extent of such inconsistency.

Section 4 Effective Date. This ordinance shall take effect upon final adoption and publication in accordance with law.
