TOWNSHIP OF EWING
ORDINANCE NO. 15-13

AN ORDINANCE AMENDING THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF EWING IN THE COUNTY OF MERCER TO AMEND CHAPTER 172 FEES

BE IT ORDAINED by the Council of the Township of Ewing, County of Mercer that the Code of the Township of Ewing be amended as follows:

Section 1 §172-5 Board of Health, is hereby amended as follows:

- A. Analysis of water samples: \$10 plus actual laboratory costs.
- B. Birth certificate: certified copy: \$15.
- C. Burial, transit or removal permit: \$10.
- D. Duplicate burial, transit or removal permit: \$10.
- E. Correction to vital record, including birth certificates, death certificates, marriage/remarriage licenses, civil union licenses, and domestic partnership registrations: \$30.
- F. Death certificate, certified copy: \$15.
- G. Certified copies of marriage/remarriage license, civil union/reaffirmation license, and domestic partnership registration: \$15.
- H. Fee for marriage/remarriage license, civil union/reaffirmation license, and domestic partnership registration: \$28.
- I. Witnessing of soil logs, perks, etc., minimum two (2) holes: \$100 base charge.
- J. Additional charge for each hole above the base charge: \$50 per hole.
- K. Witnessing a septic system abandonment (not in conjunction with a new or altered system): \$50.
- L. Certification of Laboratory water analysis report: \$30.
- M. Fee for re-audit of daycare center, preschool or school due to immunization noncompliance, each visit: \$50.
- N. Fees for activities associated with the New Jersey Smoke-Free Air Act, Chapter 383, pursuant to N.J.S.A. 26:3D-55 et seq. and N.J.A.C. 8:6 are herein fixed as follows:
 - (1) Fees for the Review and processing of Notice of Claim of Exemption of Tobacco Retail Establishment: \$50.
 - (2) Review and processing of Application for Registration of Exempt Cigar Bar or Cigar Lounge: \$100.
 - (3) Review and processing of Application for Renewal of Registration of exempt Cigar Bar or Cigar Lounge: \$50.

Section 2 Severability. Should any section, clause, sentence, phrase or provision of this article be declared unconstitutional or invalid by a court of competent jurisdiction, such decision shall not affect the remaining portions of this article.

Section 3 Repealer. All prior ordinances or parts of same inconsistent with any provisions of this article are hereby repealed to the extent of such inconsistency.

Section 4 Effective Date. This ordinance shall take effect upon final adoption and publication in accordance with law.
