AN ORDINANCE AUTHORIZING THE PRIVATE SALE OF PERSONAL PROPERTY NO LONGER NEEDED FOR PUBLIC USE, SPECIFICALLY FIRE EQUIPMENT, TO THE ROOSEVELT VOLUNTEER FIRE COMPANY, A DULY INCORPORATED MUNICIPAL FIRE COMPANY

WHEREAS, the Township has determined that the following personal property owned by the Township consisting of fire equipment is no longer needed for municipal purposes by the West Trenton Volunteer Fire Company:

Bunker Coats

- (10) Chief Cain
- (15) Cairns
- (4) Globe

WHEREAS, pursuant to N.J.S.A. 40A:12-21.1, Township Council can authorize the private sale of such personal property for nominal consideration to any organization listed in N.J.S.A. 40A:12-21; and,

WHEREAS, the Roosevelt Volunteer Fire Company is a duly incorporated municipal fire company under N.J.S.A. 40A:12-21(a) to which municipalities may make private sales of personal property for nominal consideration; and

WHEREAS, the Roosevelt Volunteer Fire Company has contacted the Township to express its need for unneeded fire equipment.

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of Ewing, as follows:

Section 1.

The following personal property owned by the Township of Ewing, consisting of fire equipment, which is no longer needed for municipal purposes by the West Trenton Volunteer Fire Company:

Section 2.

This Ordinance shall take effect as provided by law.

STATEMENT

This Ordinance authorizes the private sale of fire equipment no longer needed for municipal purposes by the West Trenton Volunteer Fire Company to the Roosevelt Volunteer Fire Company, a duly incorporated municipal fire company.
