1. The Clerk read (**Ordinance #14-25**) AN ORDINANCE AMENDING THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF EWING IN THE COUNTY OF MERCER, TO AMEND CHAPTER 91 ALCOHOLIC BEVERAGES

ORDINANCE(S) FOR SECOND READING, PUBLIC HEARING AND FINAL ADOPTION

1. The Clerk read (**Ordinance #14-23**) AN ORDINANCE OF THE TOWNSHIP OF EWING IN THE COUNTY OF MERCER, AMENDING THE REVISED ORDINANCES OF THE TOWNSHIP OF EWING, AMENDING SECTION 225-52, ENTITLED "SCHEDULE V: HANDICAPPED PARKING ON STREETS," TO ADD A HANDICAPPED PARKING SIGN AT 34 STOUT AVENUE

BE IT ORDAINED by the Township Council of the Township of Ewing that the Revised General Municipal Ordinances of the Township of Ewing be amended to provide for the designation of a handicapped parking sign at 34 Stout Avenue, as follows:

Section 1 CHAPTER 225, VEHICLES AND TRAFFIC, ARTICLE VIII Schedules, §225-52. Schedule V: Handicapped Parking on Streets, of the Code of the Township of Ewing, is hereby amended as follows:

§225-52. Schedule V: Handicapped Parking on Streets.

In accordance with the provisions of § 225-9A, restricted parking spaces for use by handicapped persons with special vehicle identification cards shall be prescribed in the following locations:

Name of Street	Location
Stout Avenue	One parking space in front of 34 Stout Avenue

Section 2 This Ordinance shall take effect after final publication according to law.

STATEMENT

This Ordinance amends the Revised General Municipal Ordinances of the Township of Ewing to provide for the designation of one handicapped parking space at 34 Stout Avenue.

President Baxter said that this will provide a handicapped parking space for the resident at this address. It has been vetted by our Police Department.

- 2. The Clerk read (Ordinance #14-24) AN ORDINANCE CHANGING THE NAME OF PART OF SAM WEINROTH ROAD NEAR TRENTON-MERCER AIRPORT TO AIRPORT CORPORATE DRIVE**

WHEREAS, the Township deems the promotion of the Trenton-Mercer Airport to be in the public interest; and

WHEREAS, the Township desires to facilitate rebranding efforts of the area surrounding the Trenton-Mercer Airport; and

WHEREAS, as part of the rebranding effort, the Township desires to change the name of Sam Weinroth Road east of West Piper Avenue to Airport Corporate Drive.

WHEREAS, the Township has the authority to change street names within its boundaries.

NOW THEREFORE, BE IT ORDAINED, by the Township Council of the Township of Ewing that Sam Weinroth Road east of West Piper Avenue shall be renamed Airport Corporate Drive.

BE IT FURTHER ORDAINED, that the Township is authorized to take all necessary actions to effectuate the said street name change.

BE IT FURTHER ORDAINED, that this Ordinance shall take effect upon final passage and publication according to law.

STATEMENT

This Ordinance changes the name of Sam Weinroth Road east of West Piper Avenue to Airport Corporate Drive.

The Attorney described where this is located.

4. The Clerk read (**Resolution #14R-173**) RESOLUTION AUTHORIZING THE PURCHASE OF TWO (2) JEEP PATRIOT 4 X 4 SPORT VEHICLES FOR USE IN THE PUBLIC HEALTH DEPARTMENT HERTRICH FLEET SERVICES AS PER STATE CONTRACT T2007

The CFO said that this is the purchase of two replacement vehicles for the Health Department.

President Baxter asked why is it state contract.

The CFO said that it is a more simple transaction because we do not have to go out to bid; the State has already done that.

There were no additional questions from Council.

Peter Boughton (119 Florence Avenue) asked the CFO if there was any consideration given to fuel economy or any other aspect that would reduce the cost over the lifetime of the vehicle.

The CFO responded, no – fuel economy vehicles are much more expensive and are not always on state contract.

Mr. Boughton suggested that, in the future, aspects such as vehicle reliability, maintenance costs and fuel economy - the total annual cost - be considered.

The Administrator said that the Health Department does have one alternative energy vehicle and this would be our intent for future purchases.

George Steward (30 Gilmore Road) said that his only objection is that this item was not even on the Agenda for this evening. The Public does not know that there are two new cars being purchased tonight.

The Administrator replied that the Ordinance to reappropriate funds for this purpose had a public hearing and was passed at the last meeting.

Mr. Steward reiterated his objection to having both the Agenda and Regular Session Council meetings on the same night. These things need to be vetted, to let people know and give people time to consider their decisions.

There were no additional questions or comments from the Public. Ms. Keyes-Maloney the moved the Resolution, seconded by Ms. Steward. President Baxter asked for a roll call.
