AN ORDINANCE AMENDING THE REVISED GENERAL MUNICIPAL ORDINANCES OF THE TOWNSHIP OF EWING, IN THE COUNTY OF MERCER, TO PROVIDE FOR TWO HOUR PARKING ON THE PRIVATE STREETS AND PARKING AREAS WITHIN THE COLLEGE OF NEW JERSEY CAMPUS TOWN DEVELOPMENT

WHEREAS, The College of New Jersey has requested that the Township of Ewing adopt time limit parking for certain private streets and parking areas within its Campus Town development.

BE IT ORDAINED by the Township Council of the Township of Ewing that the Revised General Municipal Ordinances of the Township of Ewing be amended to provide for two hour parking on certain of the private streets and parking areas within The College of New Jersey Campus Town Development, as follows:

Section 1: Section 225-74, entitled "Schedule XXVII: Time Limit Parking for The College of New Jersey Private Streets." of the Revised General Municipal Ordinances of the Township of Ewing is hereby created:

- A. In accordance with the provisions of § 225-8, no person shall park a vehicle for longer than the time limit specified upon any of the following streets, parts of streets, or other locations, and further no person shall park a vehicle between the hours specified, for the following streets and parking areas within the College of New Jersey Campus Town Development.

Section 2 The streets and locations listed herein are private streets and parking areas and the passage of this Ordinance shall in no way act as a dedication by the owner or acceptance of such streets or parking areas by the Township, all of which shall remain privately owned and maintained.

Section 3 This Ordinance shall take effect after final passage and publication according to law.

STATEMENT

This Ordinance amends the Revised General Municipal Ordinances of the Township of Ewing to provide for two hour parking on the private streets and parking areas within The College of New Jersey Campus Town Development, at the request of owner of such private streets and parking areas, The College of New Jersey.
