

RESOLUTION NO. 1 - 2016

A Resolution appointing Mr. Bill MacAvoy to serve on the Building and Housing Code Board of Appeals of the City of Harrisburg.

WHEREAS, pursuant to the Codified Ordinances of the City of Harrisburg § 8-501.1, the City of Harrisburg shall appoint five (5) members of the Building and Housing Code Board of Appeals of the City of Harrisburg; and

WHEREAS, pursuant to § 8-501.1.A, appointment of Board members shall be made by the Mayor with the approval of Council; and

WHEREAS, pursuant to § 8-501.1.B, appointees to the Building and Housing Code Board of Appeals of the City of Harrisburg must be residents of the City; and

WHEREAS, pursuant to § 8-501.C, appointees to the Building and Housing Code Board of Appeals of the City of Harrisburg shall hold no other office or employment in the government of the City or serve on any of its boards, commissions, or authorities.

WHEREAS, reposing confidence and trust in the ability of Mr. MacAvoy to capably perform the duties incumbent upon the position, Mayor Papenfuss has appointed Mr. MacAvoy to serve on the Building and Housing Code Board of Appeals of the City of Harrisburg; and

WHEREAS, Mr. MacAvoy is a resident of the City of Harrisburg; and

WHEREAS, Mr. MacAvoy holds no other office or employment in the government of the City or serve on any of its boards, commissions, or authorities.

WHEREAS, pursuant to § 8-501.1.B, the term shall be for a three year term commencing on _____ 2016 and expiring on _____ 2019; and

WHEREAS, the qualifications of Mr. MacAvoy to serve on the Building and Housing Code Board of Appeals of the City of Harrisburg have been reviewed and considered by Council.


