


RESOLUTION NO. 32 - 2016

Moved by: 

A resolution approving the City of Harrisburg's acceptance of a right-of-way dedication offered for the purposes of widening a portion of Cona Street (between Yates Alley and Manada Street) pursuant to Chapter 7-515 of the Codified Ordinances of the City of Harrisburg.

WHEREAS, H&S Investment Company ("H&S"), as part of a land development plan, has offered a right-of-way dedication for the purposes of widening a portion of Cona Street (between Yates Alley and Manada Street); a true and correct copy of the dedication plan is attached and marked as "Exhibit A;" and


WHEREAS, the portion of Cona Street (between Yates Alley and Manada Street) to be widened is abutted by property owned by H&S Investment Company (Dauphin County Tax Parcel Numbers 01-001-019); and

WHEREAS, the land development plan incorporating the right-of-way dedication has been approved by the City by Resolution No. 5-2016 on February 11, 2016; and

WHEREAS, the City desires to accept the right-of-way dedication for the purposes of widening the portion of Cona Street (between Yates Alley and Manada Street).

NOW, THEREFORE, BE IT AND IT IS HEREBY RESOLVED, BY THE COUNCIL OF THE CITY OF HARRISBURG that the right-of-way dedication made by H&S Investment Company ("H&S") for a portion of Cona Street (between Yates Alley and Manada Street) is accepted by the City of Harrisburg.

BE IT FURTHER RESOLVED that the Mayor, City Controller and other appropriate City officials are authorized and directed to take all steps necessary to further effectuate the purpose of this resolution.
