A Resolution appointing Wayne Martin, Erika Regalado, and Bruce Weber as the City of Harrisburg's designees to file the Annual State Liquid Fuels Tax Actual Usage Report on-line.

WHEREAS, the Pennsylvania Department of Transportation ("PennDOT") and the City of Harrisburg have agreed to use the **dotGrants** on-line reporting system to file the required Liquid Fuels form; and

WHEREAS, PennDOT requires a resolution of the legislative body of each municipality that participates in the on-line reporting system approving the designation of employees who are authorized to file the annual report on-line.

NOW, THEREFORE, BE IT AND IT IS HEREBY RESOLVED BY THE COUNCIL OF THE CITY OF HARRISBURG, that the Harrisburg City Council enters into and agrees to the requirements and obligations of this on-line reporting program and approves of the appointment of Wayne Marin, City Engineer; Erika Regalado, Budget Manger; and Bruce

Weber, Finance Director as the City of Harrisburg's designees to execute and provide all information necessary for the completion of said application, and to execute all documents necessary to effect such an agreement, including but not limited to, an Electronic Access Licensing Agreement (EALA) on behalf of the City.

BE IT FURTHER RESOLVED that the City Clerk is directed to execute a certificate attesting to the adoption of this Resolution, which must be forwarded to the Pennsylvania Department of Transportation as part of the complete application.

BE IT FURTHER RESOLVED that the appropriate City officials are authorized to take all steps necessary to effectuate the purpose of this Resolution.
