A Resolution authorizing the City of Harrisburg to apply for grant funds from the Pennsylvania Department of Community and Economic Development in the amount of \$47,000.00 to be used for renovating the 4th and Emerald Playground.

WHEREAS, the City of Harrisburg ("City") is eligible to apply to the Pennsylvania Department of Community and Economic Development for \$47,000.00 in grant funds; and

WHEREAS, these funds can be used by the City's Arts, Culture, and Tourism Bureau to upgrade and renovate the 4th and Emerald Playground; and

WHEREAS, this grant will be utilized to enlist the assistance of KaBOOM!, a national ~~non-profit organization~~ that helps communities design and build safe and accessible playgrounds; and


WHEREAS, the City of Harrisburg will reimburse the Commonwealth for the State's share of any expenditure, found by DCED to be ineligible; and

WHEREAS, the City will not be required to contribute funds as a match for the grant as the total cost of the project is \$83,000 and the Pennsylvania Municipal League will contribute \$36,000.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF HARRISBURG that the City of Harrisburg Arts, Culture, and Tourism Bureau is hereby authorized to apply for grant funds awarded by the Pennsylvania Department of Community and Economic Development in the amount of \$47,000.00 to be used for to renovate the 4th and Emerald Playground.

BE IT FURTHER RESOLVED that all of the appropriate City officials are authorized to take all steps necessary to effectuate the purpose of this Resolution.


