

RESOLUTION No. 51 of 2014

A Resolution appointing Mr. Thomas Leonard to serve on the Zoning Hearing Board of the City of Harrisburg.

WHEREAS, pursuant to section 7-305.1 of the Codified Ordinances and authorized by the Pennsylvania Municipalities Planning Code, the Zoning Hearing Board shall consist of three (3) members; and

WHEREAS, the terms of each board member shall be three (3) years and shall be staggered; and

WHEREAS, members of the Zoning Hearing Board must be residents of the City of Harrisburg;

and

WHEREAS, Mr. Leonard is a resident of the City of Harrisburg; and

WHEREAS, it is the desire of City Council to appoint Mr. Leonard to serve on the Zoning Hearing Board of the City of Harrisburg pursuant to the provisions of law; and

WHEREAS, the appointment shall be for a three (3) year term expiring June 10, 2017;

and

WHEREAS, Mr. Leonard holds no other employment or office within the City of Harrisburg government nor does he serve on any other board, commission or authority of the City of Harrisburg;

and

WHEREAS, the qualifications of Mr. Leonard to serve in such capacity have been reviewed and considered by Council; a copy of Mr. Leonard's résumé which set forth his qualifications is attached hereto and marked Exhibit "A."

NOW, THEREFORE, BE IT AND IT IS HEREBY RESOLVED BY THE COUNCIL OF THE CITY OF HARRISBURG that the Council hereby appoints Mr. Thomas Leonard to the Zoning Hearing Board of the City of Harrisburg for a three (3) year term expiring June 10, 2017.


