**WHEREAS**, pursuant to the Codified Ordinances of the City of Harrisburg § 7-331.4, persons with a knowledge of and interest in the preservation of the historic district, and who reside therein shall be appointed to the Harrisburg Architectural Review Board; and

**WHEREAS**, reposing confidence and trust in the ability of Ms. Bennett to capably perform the duties incumbent upon the position, Mayor Papenfuse has appointed Ms. Bennett to serve on the Harrisburg Architectural Review Board; and

**WHEREAS**, Ms. Bennett has a knowledge of and an interest in the preservation of the historic district, and resides therein; and

**WHEREAS**, Ms. Bennett's qualifications to serve on the Harrisburg Architectural Review Board have been carefully reviewed and considered by City Council. A copy of Ms. Bennett's résumé is attached hereto as Exhibit "A" and incorporated herein as if fully set forth.


