RESOLUTION NO. 93 of 2014

A Resolution appointing Ms. Staci Basore to serve on the License and Tax Appeal Board for the City of Harrisburg.

WHEREAS, Ordinance No. 1-1971 established a License and Tax Appeal Board A) to hear all appeals due to the action of the person or persons designated to administer any ordinance of the City relating to the issuance of licenses or the imposition of taxes other than real estate taxes, B) after a hearing, and based upon findings of fact, to issue an order affirming, modifying, amending, or revoking the action of the aforesaid administrator or administrators, C) to hear and determine any requests for the refund of taxes, license fees, interest, or penalties paid to the City relative to the imposition of any taxes or license fees other than real estate taxes; and

WHEREAS, the License and Tax Appeal Board shall be comprised of three (3) members to be appointed by the Mayor pursuant to section 5-101.1 of the Codified Ordinances; and

WHEREAS, the terms of each Board appointee shall be three (3) years and shall be so fixed that the term of office of one member shall expire each year; and

WHEREAS, appointees to the License and Tax Appeal Board must reside in the City of Harrisburg; and

WHEREAS, appointees to the License and Tax Appeal Board shall hold no other office in the City; and

WHEREAS, at least one appointee to the License and Tax Appeal Board shall be a certified public accountant; and

WHEREAS, Ms. Basore is a resident of the City of Harrisburg; and

WHEREAS, Ms. Basore holds no employment within the City of Harrisburg government nor with any related entity; and

WHEREAS, Ms. Basore is currently the co-owner of Mangia Qui and Suba Tapas Bar in

Harrisburg, PA; and

WHEREAS, Ms. Basore has co-owned said restaurants for approximately twelve (12) years; and

WHEREAS, the qualifications of Ms. Basore to serve in such capacity have been carefully reviewed and considered by Council; and

WHEREAS, it is the desire of City Council to approve Ms. Basore to serve on the License and Tax Appeal Board pursuant to the provisions of law; and

NOW, THEREFORE, BE IT AND IT IS HEREBY RESOLVED BY THE COUNCIL OF THE CITY OF HARRISBURG that the Council hereby approves the appointment of Ms. Staci Basore to the License and Tax Appeal Board for the City of Harrisburg for a term commencing on 11/12/14 and expiring on 11/12/17
