A Resolution approving the disposal of certain personal property owned by the City of Harrisburg that is no longer able to be used and holds no value for sale or donation purposes.

WHEREAS, periodically the City will have certain personal property which is no longer able to be used for public or municipal purposes; and


WHEREAS, any director of a department or bureau may identify and recommend disposal of City owned machinery, equipment, or materials that are obsolete or in disrepair; and

WHEREAS, Section 12402.1(c) of the Third Class City Code provides that “[n]o personal property of the city shall be disposed of, by sale or otherwise, except upon approval of council by resolution[;]” and

WHEREAS, certain personal property owned by the City specifically set forth and described in “Exhibit A” has been identified as no longer able to be used and no longer holding value due to age and/or condition.

NOW, THEREFORE, BE IT AND IT IS HEREBY RESOLVED BY THE COUNCIL OF THE CITY OF HARRISBURG, that the disposal of certain personal property owned by the City of Harrisburg attached as “Exhibit A” and incorporated as if fully set forth is approved and is to be implemented immediately.

BE IT FURTHER RESOLVED, that the Mayor, Controller, Finance Director and all other appropriate City officials are authorized and directed to take all steps necessary to effectuate this Resolution.


